**INTELLECTUAL PROPERTY PARTIAL RELEASE**

This Intellectual Property Partial Release is entered into as of January 30, 2023 by PNC BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity, the “Agent”) for the lenders pursuant to that certain Patent, Trademark and Copyright Security Agreement, dated as of October 28, 2010 (as amended prior to the date hereof, the “IP Security Agreement”), by and among each of the Pledgors party thereto and the Agent, whereby the Pledgors granted to the Agent a security interest in the Patents, Trademarks and Copyrights (as defined therein), including the trademarks set forth in Schedule I hereto.

3. The Agent hereby reassigns, grants and conveys to Invacare, without any representation, warranty, recourse or undertaking by the Agent, all of the Agent’s right, title and interest in and to the Specified Trademark Collateral specifically described and set forth on Schedule 1 hereto.
