NOTICE OF AGENCY RESIGNATION AND ASSIGNMENT OF SUPER-PRIORITY TERM LOAN INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT

THIS NOTICE OF RESIGNATION AND ASSIGNMENT OF SUPER-PRIORITY TERM LOAN INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT (this "Assignment") is made and entered into as of February 6, 2023 by UBS AG, STAMFORD BRANCH, as the resigning Administrative Agent (in such capacity, "Assignor"), in favor of WILMINGTON SAVINGS FUND SOCIETY, FSB, not in its individual capacity but solely as successor Administrative Agent, with an address of 500 Delaware Avenue, Wilmington, DE 19801, as the successor administrative agent (in such capacity, "Assignee").

WITNESSETH

WHEREAS, Assignor is party to that certain Super-Priority Pledge and Security Agreement, dated as of June 22, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Serta Simmons Bedding, LLC, a Delaware limited liability company ("SSB"), National Bedding Company L.L.C., an Illinois limited liability company ("National Bedding"), and SSB Manufacturing Company, a Delaware corporation ("SSB Manufacturing" and, together with SSB and National Bedding, the "Borrowers"), Dawn Intermediate, Inc., a Delaware corporation ("Holdings"), each of the subsidiaries party thereto (the "Subsidiary Guarantors" and together with the Borrowers and Holdings, the "Grantors") and Assignor;

WHEREAS, pursuant to (i) the Security Agreement and (ii) the Super-Priority Term Loan Intellectual Property Security Agreement Supplement, dated as of December 23, 2022 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time), by SSB, Dreamwell, Ltd., a Nevada limited liability company ("<u>Dreamwell</u>"), and Tuft & Needle, LLC, a Delaware limited liability company ("<u>T&N</u>"), in favor of Assignor submitted or recorded, as applicable, with the United States Patent and Trademark Office (the "<u>USPTO</u>") as follows:

- (a) submitted to the USPTO on December 23, 2022, but not yet recorded, with respect to the trademarks owned by Dreamwell, T&N and SSB listed on <u>Schedule I</u> hereto,
- (b) recorded at USPTO on December 23, 2022 at Reel/Frame 062212/0165 with respect to patents owned by Dreamwell, and at Reel/Frame 062212/0310 with respect to patents owned by T&N,

(the "Super-Priority Term Loan Intellectual Property Security Agreement Supplement"), the Grantors granted to Assignor a security interest in and to the Additional IP Collateral (as defined in the Super-Priority Term Loan Intellectual Property Security Agreement Supplement), including (1) the trademark registrations and applications set forth on Schedule II, (2) the patents and patent applications set forth on Schedule III, and (3) the copyrights and copyright applications set forth on Schedule III (the "Assigned IP Collateral");

WHEREAS, pursuant to that certain Successor Agent Appointment and Agency Transfer Agreement ("Agent Assignment"), dated as of February 6, 2023, among the Grantors, the other parties thereto, Assignor and Assignee, Assignor resigned as Administrative Agent under the Credit Agreement and other Loan Documents, and Assignee accepted its appointment as such under the Credit Agreement and other Loan Documents, and Assignor assigned and transferred to Assignee each of the Liens and security interests granted to the Assignor under the Loan Documents; and

WHEREAS, Assignor and Assignee desire to enter into this Assignment to evidence the

resignation of Assignor as the Administrative Agent, the appointment of Assignee as the Administrative Agent, and the assignment by Assignor to Assignee of the Super-Priority Term Loan Intellectual Property Security Agreement Supplement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby covenant and agree as follows:

- 1. <u>Terms.</u> Capitalized terms used in this Assignment and not otherwise defined herein shall have the meanings as specified or otherwise used in the Agent Assignment.
- 2. <u>Assignment</u>. Assignor hereby transfers, assigns, grants and conveys to Assignee for the ratable benefit of the Secured Parties all of its right, title and interest in, to and under the Security Agreement and the Super-Priority Term Loan Intellectual Property Security Agreement Supplement, including, without limitation, its security interest in, and Lien on, the Assigned IP Collateral granted pursuant to the foregoing agreements, and Assignee hereby accepts and assumes the foregoing assignment and all of such right, title, interest, security interests and Lien. The foregoing assignment is made without recourse to Assignor, and without representation or warranty of any kind.
- 3. <u>Governing Law</u>. This Agreement shall be governed by and construed in accordance with the laws of the State of New York.
- 4. <u>Counterparts</u>. This Assignment may be executed in counterparts, each of which shall constitute an original and all of which taken together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile transmission or electronic mail shall be as effective as delivery of a manually executed counterpart of this Assignment.
