RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), effective as of November 25, 2022 is made by Alter Domus (US) LLC, in its capacity as collateral agent (referred to herein as the “Agent”), in favor of Weider Publications, LLC, a Delaware limited liability company (the “Company”).

WHEREAS, the Company, the Agent and certain other parties entered into that certain Pledge and Security Agreement, dated as of February 11, 2022 (as amended, restated, amended and restated, supplemented, modified or otherwise changed from time to time, the “Security Agreement”);

WHEREAS, in connection with the Security Agreement, the Company executed and delivered the Notice of Grant of Security Interest in Trademarks, dated as of February 11, 2022, in favor of the Agent (the “Trademark Security Agreement”);

WHEREAS, the Company, the Agent and certain other parties entered into that certain Pledge and Security Agreement, dated as of June 7, 2022 (as amended, restated, amended and restated, supplemented, modified or otherwise changed from time to time, the “June Security Agreement”);

WHEREAS, in connection with the June Security Agreement, the Company executed and delivered the Notice of Grant of Security Interest in Trademarks, dated as of June 7, 2022, in favor of the Agent (the “June Trademark Security Agreement”);

WHEREAS, pursuant to the Security Agreement and Trademark Security Agreement, the Company pledged and granted to the Agent for the benefit of the other Secured Parties a lien on and continuing security interest in all right, title and interest in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the “Collateral”), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

WHEREAS, the Agent recorded its security interest in the Released Trademarks with the United States Patent and Trademark Office (the “USPTO”) on February 15, 2022 at Reel/Frame No. 7634/0303; and

WHEREAS, the Company has requested, and the Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Collateral listed on Schedule A attached hereto (the “Released Trademarks”);

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees, for the benefit of the Company, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement and Trademark Security Agreement, as applicable.

SECTION 2. Release of Security Interest. The Agent hereby releases, relinquishes, terminates, cancels and discharges its continuing security interest in the Released Trademarks.

SECTION 3. Effect of Release. Nothing contained herein shall in any way impair the validity or enforceability of the June Security Agreement or June Trademark Security Agreement, as modified hereby, or alter, waive, annul, vary, affect, or impair any provisions, conditions, or covenants contained therein or any rights, powers, or remedies granted therein.

SECTION 4. Further Assurances. The Agent hereby authorizes the Company or the Company's authorized representative to record this Release with the USPTO. The Agent further agrees to execute and deliver (at the direction of the Required Lenders) to the Company any and all further documents and instruments, and do any and all further acts which the Company reasonably requests in writing (at the Company's sole cost and expense) in order to confirm this Release and the Company's right, title and interest in, to and under the Released Trademarks.


SECTION 5. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.

SECTION 6. Counterparts. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart by facsimile or electronic mail shall be equally effective as delivery of an original executed counterpart.
