## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release“), dated as of March 23, 2020, is executed by LBC CREDIT AGENCY SERVICES, LLC, a Delaware limited liability company, as agent under the Credit Agreement (as defined below) (in such capacity, “Agent“), in favor of KLO ACQUISITION, LLC, a Delaware limited liability company (together with its affiliates, “KLO“).

### **WITNESSETH:**

**WHEREAS**, KLO has executed that certain Pledge and Security Agreement, dated as of December 30, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement“; capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement) in favor of Agent for the benefit of the lenders under that certain Amended and Restated Credit Agreement, dated as of April 7, 2017 (collectively, the “Lenders“);

**WHEREAS**, in accordance with the Security Agreement, KLO has executed (i) that certain Notice of Grant of Security Interest in Trademarks recorded with the Canadian Intellectual Property Office on September 3, 2019, as File No. 1714179, (ii) that certain Notice of Grant of Security Interest in Trademarks recorded with the United States Patent and Trademark Office (the “USPTO“) on August 5, 2019, as Reel/Frame 6712/0346, (iii) that certain Notice of Grant of Security Interest in Trademarks recorded with the USPTO on June 25, 2019, as Reel/Frame 6678/0032, and (iv) that certain Notice of Grant of Security Interest in Trademarks recorded with the USPTO on February 15, 2017, as Reel/Frame 5989/0327 (the agreements described in clauses (i), (ii), (iii), and (iv), collectively, the “Trademark Security Agreements“);

**WHEREAS**, pursuant to the Trademark Security Agreements, KLO pledged and granted a security interest in the trademarks that are the subject of the applicable registration and serial/application numbers listed on the Exhibit A hereto (such trademarks, collectively the “Marks“);


**WHEREAS**, on February 11, 2020, KLO entered into that certain Asset Purchase Agreement, pursuant to which KLO sold, among other things, the Marks to 185 West Main Financial, LLC (the “KLO Asset Sale“); and

**WHEREAS**, on February 11, 2020, KLO and Agent entered into that certain Consent Under Amended and Restated Credit Agreement, pursuant to which Agent consented to the KLO Asset Sale.

**NOW, THEREFORE**, in consideration of the foregoing, Agent, acting for and on behalf of, and in its capacity as agent for, the Lenders, hereby releases its liens on and security interests in the Marks. Except as expressly amended by this Release, the terms of the Trademark Security Agreements shall remain in full force and effect as executed.

**IN WITNESS WHEREOF**, Agent has caused this instrument to be duly executed by an authorized representative and delivered as of the date first above written.
