**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENTS**

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS (this “Termination and Release”) is made as of the 21st of March, 2023, by EAST WEST BANK (the “Agent”) to Western’s Smokehouse, LLC, a Missouri limited liability company, Western’s Smokehouse & Meat Market, LLC, a Missouri limited liability company and Thrushwood Farms Quality Meats, Inc., a Delaware corporation (each a “Grantor” and together the “Grantors”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the applicable Trademark Security Agreement (defined below) or the Security Agreement (defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement, dated as of December 23, 2019, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among, *inter alios*, the Grantors and the Agent, the Grantors executed that certain Trademark Security Agreement, dated as of January 23, 2020, which was recorded in the United States Patent and Trademark Office at Reel 6846, Frame 0618 on January 27, 2020 and that certain Trademark Security Agreement, dated April 12, 2021, which was recorded in the United States Patent and Trademark Office at Reel 7254, Frame 0132 on April 13, 2021 (each a “Trademark Security Agreement” and together the “Trademark Security Agreements”), pursuant to which the Grantors granted a security interest to the Agent in the Grantors’ Trademarks, including certain trademarks and/or trademark applications listed on Schedule A attached hereto and made a part hereof.

WHEREAS, the Agent now desires to terminate and release its security interest in the Trademarks and reassign any and all rights, title, and interest in the same to the Grantors;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Agent hereby releases its security interest in all of the Grantors’ right, title and interest in and to the Trademarks and all goodwill associated therewith, including those Trademarks set forth on Schedule A.

2. If and to the extent that the Agent has acquired any right, title or interest in or to any of the Trademarks, the Agent hereby reassigns, grants and conveys to the Grantors, without any representation, warranty, recourse or undertaking by the Agent, any and all of its right, title, and interest in and to the Trademarks (including without limitation those Trademarks set forth on Schedule A), along with any goodwill in the Trademarks that the Agent may have acquired.


3. This Termination and Release, and any claims, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Termination and Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the law of the State of New York.
