RELEASE OF SECURITY INTEREST

This Release of Security Interest, dated as of March 8, 2023 (the "Release"), by COMERICA BANK, a Texas banking association ("Bank") in favor of ARCADIA SOLUTIONS, LLC, a Minnesota limited liability company ("Grantor") with its principal place of business located at 320 Summer Street, 3rd Floor, Boston, MA 02210.

Recital

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of November 7, 2012 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Original IP Security Agreement"), by and between Grantor and Bank and that certain Amended and Restated Intellectual Property Security Agreement, dated as of July 31, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time and, together with the Original IP Security Agreement, the "Security Agreements"), by and between Grantor and Bank, Grantor granted to Bank a security interest in the copyrights, patents and trademarks of Grantor, including in the copyrights, patents and trademarks described on Exhibits A - C, respectively, attached hereto (collectively, the "Intellectual Property Collateral"), and submitted for recordation and/or recorded with the Library of Congress Copyright Office as set forth on Exhibit A and recorded with the US Patent and Trademark Office as set forth on Exhibits B-C.

WHEREAS, Grantor has no outstanding obligations to Bank under the terms of the Security Agreement, and pursuant to that certain Payoff Letter, dated as of the date hereof, by and between Grantor and Bank, Bank agrees to release its security interest in the Intellectual Property Collateral.


Agreement

Now therefore, Bank agrees that it terminates and releases its security interest in the Intellectual Property Collateral and reassigns to Grantor, without warranty or recourse, all interest of Bank in the Intellectual Property Collateral, including the Intellectual Property Collateral listed on Exhibits A-C attached hereto, and any right, title or interest of Bank to the Intellectual Property Collateral shall hereby cease and become void. If, and to the extent that, Bank has acquired any right, title or interest in and to the Intellectual Property Collateral, Bank, on behalf of itself, its successors, legal representatives and assigns, unconditionally re-transfers, re-conveys and re-assigns such right title or interest to the Grantor.

Bank authorizes the recordation of this with the US Patent and Trademark Office and the Library of Congress Copyright Office.
