**SUPPLEMENT NO. 1
TO
TRADEMARK SECURITY AGREEMENT**

April 14, 2023

WHEREAS, MOUNTAIN ORIGINS DESIGN LLC, a Wyoming limited liability company (“Grantor”), and JPMorgan Chase Bank, N.A. (the “Lender”), are parties to that certain Trademark Security Agreement, dated as of September 17, 2021 (as the same may be amended or supplemented from time to time, the “Trademark Security Agreement”; capitalized terms used but not defined herein shall have the meanings specified in the Trademark Security Agreement), pursuant to which the Grantor granted to the Lender, to secure the prompt payment and performance in full when due of the Secured Obligations, a security interest in all of the Grantor’s right, title and interest in, to and under Trademark Collateral arising under the laws of the United States of America, now owned or at any time hereafter acquired by the Grantor;

WHEREAS, the Grantor has acquired or created additional Trademark Collateral since the date of execution of the Trademark Security Agreement; and

WHEREAS, Schedule I to the Trademark Security Agreement does not reflect all Trademark Collateral acquired or created by the Grantor since the date of execution of the Trademark Security Agreement.

THEREFORE,

A. The Grantor hereby grants to the Lender to secure the prompt payment and performance in full when due of the Secured Obligations, a continuing first priority security interest in all of the Grantor’s right, title and interest in, to and under Trademark Collateral arising under the laws the United States of America, now owned or at any time hereafter acquired by the Grantor, including the Trademark Collateral added to Schedule I of the Trademark Security Agreement pursuant to paragraph B below.

B. The Trademark Security Agreement is hereby supplemented, effective as of the date hereof, by amending Schedule I thereof so as to add the Trademark Collateral listed on Schedule A hereto.

This Supplement No. 1 to Trademark Security Agreement (this “Supplement”) has been executed and delivered by the Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Lender in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The Security Agreement (and all rights and remedies of the Lender and Secured Parties thereunder) shall remain in full force and effect in accordance with its terms.

Except as expressly supplemented hereby, the Trademark Security Agreement shall continue in full force and effect in accordance with the provisions thereof on the date hereof. As used in the Trademark Security Agreement, the terms “Agreement,” “this Agreement,” “herein,” “hereafter,” “hereto,” “hereof” and words of similar import, shall, unless the context otherwise requires, mean the Trademark Security Agreement as supplemented by this Supplement.

Except as expressly supplemented hereby, the Trademark Security Agreement and all documents contemplated thereby, are each hereby confirmed and ratified by the Grantor.

The execution and filing of this Supplement, and the addition of the Trademark Collateral set forth herein are not intended by the parties to derogate from, or extinguish, any of the Lender's or any Secured Party's rights or remedies under (i) the Trademark Security Agreement and/or any agreement, amendment or supplement thereto or any other instrument executed by the Grantor and heretofore recorded or submitted for recording in the U.S. Patent and Trademark Office, or (ii) any financing statement, continuation statement, deed or charge or other instrument executed by the Grantor and heretofore filed in any state or county in the United States of America or elsewhere.



Each party agrees that the electronic signatures of the parties included in this Supplement are intended to authenticate this writing and to have the same force and effect as manual signatures. As used herein, "electronic signatures" mean any electronic sound, symbol, or process attached to or logically associated with a record and executed and adopted by a party with the intent to sign such record pursuant to the New York Electronic Signatures and Records Act (N.Y. State Tech. §§ 301-309) as amended from time to time or as provided under the Uniform Commercial Code as adopted by the State of New York.

This Supplement shall be governed by, and construed in accordance with, the internal laws (and not the law of conflicts) of the State of New York, but giving effect to federal laws applicable to national banks. **THIS SUPPLEMENT SHALL BE SUBJECT TO THE PROVISIONS REGARDING GOVERNING LAW; JURISDICTION; AND CONSENT TO SERVICE OF PROCESS SET FORTH IN SECTION 8.15 OF THE SECURITY AGREEMENT, AND SUCH PROVISIONS ARE INCORPORATED HEREIN BY THIS REFERENCE, MUTATIS MUTANDIS.**
