**TRADEMARK SECURITY AGREEMENT**

This Trademark Security Agreement (“**Trademark Security Agreement**”), dated as of April 4, 2023, is made by UNIGROUP, C.A., a Missouri cooperative association (“**Borrower**”), MAYFLOWER TRANSIT LLC, a Missouri limited liability company (“**Mayflower**”), TRANS ADVANTAGE, INC., a Delaware corporation (“**Advantage**”), UNIGROUP WORLDWIDE LOGISTICS, LLC, a Missouri limited liability company (“**Logistics**”), UNIGROUP WORLDWIDE, INC., a Missouri corporation (“**Worldwide**”) and UNITED VAN LINES, LLC, a Missouri limited liability company (“**United**” and, together with Borrower, Mayflower, Advantage and Logistics, collectively, the “**Grantors**” and each individually, a “**Grantor**”) in favor of JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent for the Lenders under the Credit Agreement referred to below (the “**Secured Party**”).

WHEREAS, each Grantor and Secured Party have entered into that certain Credit Agreement dated as of April 4, 2023 (the “**Credit Agreement**”). All capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement.

WHEREAS, each Grantor has, pursuant to that certain Pledge and Security Agreement, dated as of April 4, 2023 (the “**Security Agreement**”) granted to Secured Party a security interest in, among other property, certain intellectual property of the Grantors in order to secure the Obligations, and has agreed to execute and deliver this Trademark Security Agreement, for recording with national, federal and state government authorities, including, but not limited to, the United States Patent and Trademark Office. Each Grantor is entering into this Trademark Security Agreement in order to induce the Lenders to enter into and extend credit to the Borrower under the Credit Agreement.

NOW, THEREOFRE, the Grantors and Secured Party agree as follows:

1. **Grant of Security.** Each Grantor hereby grants to Secured Party a security interest in and to all of the right, title and interest of the Grantors in, to and under the following, wherever located, and whether now existing or hereafter arising or acquired from time to time (the “**Trademark Collateral**”):

(a) the trademark registrations, trademark applications, and trademark licenses set forth in **Schedule 1** hereto, together with the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof (the “**Trademarks**”), excluding only United States intent-to-use trademark applications to the extent that and solely during the period in which the grant of a security interest therein would impair, under applicable federal law, the registrability of such applications or the validity or enforceability of registrations issuing from such applications;

(b) all rights of any kind whatsoever of each Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(c) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. **Recordation.** Each Grantor authorizes the Commissioner for Trademarks and any other government officials to record and register this Trademark Security Agreement upon Secured Party's request.

3. **Loan Documents.** This Trademark Security Agreement has been entered into pursuant to and in conjunction with the Security Agreement, which is hereby incorporated by reference. The provisions of the Security Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of Secured Party with respect to the Trademark Collateral are as provided by the Credit Agreement and related documents, and nothing in this Trademark Security Agreement shall be deemed to limit such rights and remedies.

4. **Execution in Counterparts.** This Trademark Security Agreement may be executed in any number of counterparts, each of which shall be an original, and all of which, when taken together, shall constitute one agreement. Subject to the terms of the Credit Agreement, delivery of an executed counterpart of a signature page of this Trademark Security Agreement that is an Electronic Signature transmitted by facsimile, emailed pdf. or any other electronic means that reproduces an image of the actual executed signature page shall be effective as delivery of a manually executed counterpart of this Trademark Security Agreement.

5. **Successors and Assigns.** This Trademark Security Agreement will be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns.

6. **Governing Law.** THIS TRADEMARK SECURITY AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE INTERNAL LAWS OF THE STATE OF MISSOURI, BUT GIVING EFFECT TO FEDERAL LAWS APPLICABLE TO NATIONAL BANKS.
