NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency, and adequacy of which are hereby acknowledged:


Terms

1. Assignor does hereby sell, assign, transfer and convey to Assignee, its successors, and assigns, absolutely and forever, (a) Assignor's entire right, title and interest, whether statutory or at common law, in and to the Mark in the United States and all countries throughout the world, together with the goodwill arising out of or in any way associated with such intellectual property, and (b) its entire right to bring actions for the enforcement of the Mark, including but not limited to, the right to sue for and recover damages for any past and future infringement of the intellectual property.
2. Assignor does hereby covenant and agree to execute, for no additional consideration, such further documents and do such other acts as may be necessary and proper to vest full title in and to the Mark in the Assignee or which may be necessary to obtain, renew, issue or enforce the intellectual property, including the Mark.
