pursuant to that certain Trademark Collateral Agreement, dated as of July 18, 2022, executed by Grantor and SigmaTron International, Inc., a Delaware corporation, in favor of Administrative Agent and recorded with the United States Patent and Trademark Office on July 18, 2022 at Reel/Frame 7793/0168.
