**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of May 10, 2023, is made by GLAS AMERICAS LLC (“**GLAS Americas**”), as collateral agent for the Lenders under the Credit Agreement referred to below (“**Collateral Agent**”) in favor of CATALINA MARKETING CORPORATION, MODIV MEDIA, LLC and CELLFIRE LLC (collectively, the “**Grantors**”) (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, pursuant to that certain Senior Term Loan Credit Agreement, dated as of February 15, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect as of the date hereof, the “**Credit Agreement**”), among PACIFICCO ACQUISITION CORP., a Delaware corporation (“**Holdings**”), each Person party thereto as “Parent Guarantors” (together with Holdings, the “**Parent Guarantors**”), CATALINA MARKETING CORPORATION, a Delaware corporation (the “**Borrower**”), the Subsidiary Guarantors party thereto (together with the Parent Guarantors and the Borrower, the “**Loan Parties**”), the lenders party thereto (collectively, the “**Lenders**”), GLAS USA LLC, as Administrative Agent for the Lenders (in such capacity, the “**Administrative Agent**”) and GLAS AMERICAS LLC, as Collateral Agent (in such capacity, the “**Collateral Agent**”), the Lenders agreed to make certain advances of credit and to extend certain financial accommodation to the Borrower;

WHEREAS, in connection with the Credit Agreement and pursuant to that certain Security Agreement, dated as of February 15, 2019 (the “**Security Agreement**”), the Grantors granted to Collateral Agent security interests in certain intellectual property owned by the Grantors and were required to further evidence such grant by executing and delivering certain Intellectual Property Security Agreements (as defined in the Security Agreement), including those listed on Annex I, Annex II and Annex III attached hereto (the “**Intellectual Property Collateral**”);

WHEREAS, the Patent Security Agreement was recorded in the United States Patent and Trademark Officer (the “**USPTO**”) on February 20, 2019, at Reel 048384 and Frame 0211, as subsequently assigned to the Collateral Agent pursuant to the Assignment of Patent Security Agreement, dated May 31, 2019 and recorded at the USPTO on June 6, 2019, at Reel 049392 and Frame 0838, and encumbers the Patents scheduled on Annex I hereto;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the USPTO on February 20, 2019 at Reel 6567 and Frame 0682, as assigned to the Collateral Agent pursuant to the Assignment of Trademark Security Agreement, dated May 31, 2019 and recorded at the Trademark Division of the USPTO on June 6, 2019, at Reel 6663 and Frame 0855, and encumbers the Trademarks scheduled on Annex II hereto; and

WHEREAS, the Copyright Security Agreement was recorded in the United States Copyright Office (the “**USCO**”) on March 1, 2019 and was recorded at Document Number V9977D461, as assigned to the Collateral Agent pursuant to the Assignment of Copyright Security Agreement, submitted for recording in the United States Copyright Office on June 14, 2019 at Document Number V9982D041, and encumbers the Copyrights scheduled on Annex III hereto; and

NOW THEREFORE, Collateral Agent hereby releases, relinquishes and discharges, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to any agreement or document delivered in connection with the Security Agreement and Collateral Agent hereby reassigns any and all right, title and interest granted to Collateral Agent, or (if any) that Collateral Agent may otherwise have, in the Intellectual Property Collateral to the applicable Grantors.

Collateral Agent (i) authorizes the Grantors or their authorized representatives to record this release with the USPTO and/or United States Copyright Office, as applicable, and (ii) agrees, at the Grantors' expense, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Collateral Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


