## TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this “**Agreement**”), dated as of May 9, 2023, is entered into by and among, Robertshaw Controls Company, a Delaware corporation, Robertshaw US Holdings Corp., a Delaware corporation, and Burner Systems International, Inc., a Delaware corporation (the “**Grantors**”) and Acquiom Agency Services LLC, a Colorado limited liability company, as Collateral Agent (the “**Assignee**”) pursuant to (i) that certain Super-Priority Pledge and Security Agreement, dated as of May 9, 2023, among the Assignee, the Grantors and the other Grantors party thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), and (ii) that certain Super-Priority Credit Agreement, dated as of May 9, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Financing Agreement**”), between, among others, Robertshaw US Holding Corp, each of the other Subsidiaries party hereto as a borrower, Range Parent, Inc., a Delaware corporation, the subsidiaries of Holdings from time to time party hereto as subsidiary guarantors, the Lenders (as defined therein) and the Assignee and Seaport Loan Products LLC (“**Seaport**”), as co-administrative agents for the Lenders and the Assignee, as collateral agent for the Lenders (in such capacity, the “**Collateral Agent**”).

Capitalized terms not otherwise defined herein have the respective meanings ascribed to them in the Security Agreement or the Financing Agreement, as applicable.

WHEREAS, pursuant to the Security Agreement, the Grantors have granted in favor of the Assignee a security interest in certain Collateral, including the federally registered Trademarks set forth on Schedule A hereto as of the date hereof.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantors and the Assignee hereby agree as follows:

### 1. Grant of Security Interest

(a) Subject to the terms and conditions of the Security Agreement, to evidence further the security interest granted by the Grantors to the Assignee pursuant to the Security Agreement, the Grantors hereby grant to the Assignee a security interest in all of the Grantors’ right, title and interest in, to and under the Trademarks, whether now owned or existing or at any time hereafter acquired or arising and wherever located, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Grantors’ Secured Obligations. For the purposes of this Agreement, “**Trademarks**” shall have the meaning assigned thereto in the Security Agreement.

(b) Schedule A hereto contains a true and accurate list of all of the Grantors’ federally registered United States registrations and applications for registration for the Trademarks (excluding Internet domain names) existing as of the date hereof.

(c) The security interest granted hereby is granted concurrently and in conjunction with the security interest granted to the Assignee under the Security Agreement. In the event that any of the provisions of this Agreement are in conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

### 2. Modifications

This Agreement or any provision hereof may not be changed, waived, or terminated except in accordance with the amendment provisions of the Financing Agreement. In connection with the foregoing,

the Grantors authorize the Assignee, upon notice to the Grantors, to modify this Agreement without obtaining the Grantors' signature to such modification, to the extent that such modification constitutes an amendment of Schedule A hereto, to add any right, title or interest in any Trademarks owned or subsequently acquired by the Grantors or to delete any reference to any right, title or interest in any Trademarks in which the Grantors no longer have or claims any right, title or interest. The Grantors additionally agree to execute any additional agreement or amendment hereto as may be reasonably required by the Assignee from time to time, to subject any such owned or subsequently acquired right, title or interest in any Trademark to the security interests and perfection created or contemplated hereby or by the Security Agreement.

3. Applicable Law

THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.


4. Counterparts


