RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of June 9, 2023 by The Bank of New York Mellon Trust Company, N.A., in its capacity as collateral agent (the “Collateral Agent”), in favor of the entities identified as grantors on the signature pages of the Trademark Security Agreement as defined below) (the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors executed that certain Trademark Security Agreement, dated as of May 5, 2022 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”; terms used but not defined herein shall have the meaning set forth in the Trademark Security Agreement) in favor of the Collateral Agent, pursuant to which the Grantors granted a security interest to the Collateral Agent in certain trademarks and other intellectual property of the Grantors;

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office at Reel: 007730; Frame: 0512 on May 23, 2022; and

WHEREAS, the Collateral Agent has agreed to terminate the Trademark Security Agreement and terminate and release the entirety of its security interest in all Trademark Collateral, including all of its liens on the trademarks and trademark applications of the Grantors identified on Annex 1 attached hereto and made a part hereof, and to reconvey any and all of its rights, title and interests in, to and under the Trademark Collateral to the Grantors.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement and absolutely terminates, releases, cancels and discharges the collateral pledges, grants, liens and security interests granted by the Grantors in favor of the Collateral Agent (on behalf of itself, the Purchasers and their permitted successors and assigns) in and to the Trademark Collateral, including all of its liens on the trademarks and trademark applications of the Grantors identified on Annex 1 attached hereto, and all rights, title and interests in, to and under the Trademark Collateral, including all of its liens on the trademarks and trademark applications of the Grantors identified on Annex 1 attached hereto, all without warranty or representation of any kind.


