RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of June 9, 2023 (the “Effective Date”), is made by JPMORGAN CHASE BANK, N.A., in its capacity as collateral agent (the “Agent”) in favor of WERNER CO., a Delaware corporation, WERNER TECHNOLOGIES, INC., a Delaware corporation, and KNAACK LLC, a Delaware limited liability company (each a “Grantor”, and collectively the “Grantors”). All capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in each Trademark Security Agreement, as applicable (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Term Loan Credit Facility U.S. Pledge and Security Agreement, dated July 24, 2017, by and among the Agent, the Grantors, and certain other parties (as may have been amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors executed and delivered that certain Trademark Security Agreement, dated as of July 24, 2017, which was recorded in the United States Patent and Trademark Office (“USPTO”) on July 25, 2017 at Reel/Frame 6114/0018 and that certain Trademark Security Agreement, dated as of October 4, 2021, which was recorded in the USPTO on October 4, 2021 at Reel/Frame 7441/0959 (each a “Trademark Security Agreement”, and together the “Trademark Security Agreements”);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreements, each Grantor granted to the Agent a lien on and a continuing security interest in (the “Security Interest”) all of its rights, title and interest in, to and under all its Trademarks, including, without limitation, the Trademarks set forth on Schedule A attached hereto, in each case together with all Proceeds and products of the Trademarks, all goodwill associated therewith, and all rights to sue at law or in equity for any infringement or other impairment thereof, including the right to receive all proceeds and damages therefrom (collectively, the “Trademark Collateral”); and

WHEREAS, the Grantors have requested the Agent to release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates and cancels the Trademark Security Agreements, (ii) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, and (iii) re-transfers, re-conveys and re-assigns to each Grantor all right, title or interest it may have in, to and under the Trademark Collateral of such Grantor pursuant to the Security Agreement or Trademark Security Agreements, in each case without recourse to the Agent and without representation or warranty of any kind.

Each Grantor, or any successor to such Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Release with the USPTO.

This Release shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York, without regard to conflicts of law principles thereof.


