RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of June 20, 2023 (the “Effective Date”), is made by PNC Bank, National Association, in its capacity as Agent (the “Agent”), in favor of the grantor parties identified on the signature page hereto (the “Grantors”).

WHEREAS, pursuant to that certain Amended and Restated Credit and Security Agreement, dated as of March 18, 2019, by and among the Agent, the Grantors, and certain other parties thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Loan Agreement”), the Grantors granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Loan Agreement, the Grantors executed and delivered the Grant of Security Interest in Trademark Rights, dated as of August 18, 2006, the Notice of Security Interest in U.S. Trademarks, dated as of January 30, 2009, the Notice of U.S. Security Interest in U.S. Trademarks, dated August 27, 2010, the Notice of Security Interest in U.S. Trademarks, dated January 31, 2012, the Notice of Security Interest in U.S. Trademarks, dated as of August 31, 2012, Supplement to Fourth Amended and Restated Grant of Security Interest in Trademark Rights, dated as of June 29, 2016 and the Fifth Amended and Restated Grant of Security Interest in Trademark Rights, dated as of March 18, 2019 (collectively, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreements are recorded with the United States Patent and Trademark Office at the Reel/Frame numbers listed on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Loan Agreement or the Trademark Security Agreements, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth on Schedule A attached hereto, arising under the Loan Agreement and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
