**OMNIBUS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This OMNIBUS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated as of June 23, 2023, is made by JPMORGAN CHASE BANK, N.A., as administrative agent (the “Agent”) for the Secured Parties in favor of the Grantors identified as such on Schedule I hereto (each, a “Grantor”, and collectively, the “Grantors”). Capitalized terms used but not defined herein have the meanings given to them, as applicable, directly or by reference, in the relevant IP Security Agreement (as defined below).

WHEREAS, the Grantors are party to an Amended and Restated Guarantee and Collateral Agreement, dated as of March 11, 2014 (as it may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), pursuant to which certain Grantors, as identified on Schedule I, executed and delivered in favor of the Agent (i) that certain Amended and Restated Intellectual Property Security Agreement, dated as of March 11, 2014, (ii) that certain Intellectual Property Security Agreement (Supplemental Filing), dated as of March 9, 2016, (iii) that certain Intellectual Property Security Agreement (Supplemental Filing), dated as of May 31, 2017, (iv) that certain Intellectual Property Security Agreement (Supplemental Filing), dated as of September 18, 2019, and (v) that certain Intellectual Property Security Agreement (Supplemental Filing), dated as of May 10, 2021 (each, an “IP Security Agreement” and collectively, the “IP Security Agreements”);

WHEREAS, the IP Security Agreements were recorded in the United States Patent and Trademark Office (“USPTO”) and the United States Copyright Office (“USCO”) with respect to certain intellectual property collateral of each applicable Grantor, on the dates and at the locations specified in Schedule I;

WHEREAS, pursuant to the Security Agreement and the IP Security Agreements, each Grantor granted to the Agent, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in and to the following property then owned or at any time thereafter acquired by such Grantor or in which such Grantor had or at any time in the future may have acquired any right, title or interest (the “IP Collateral”):

- (a) (i) all United States trademarks, service marks, trade names, domain names, corporate names, company names, business names, trade dress, trade styles or logos and all registrations of and applications to register the foregoing (except for any applications filed in the United States Patent and Trademark Office on the basis of the Grantor’s “intent-to-use” such trademark, unless and until acceptable evidence of use of the trademark has been filed with the United States Patent and Trademark Office pursuant to Section 1(c) or Section 1(d) of the Lanham Act (15 U.S.C. 1051, et seq.), to the extent, if any, that, and during the period, if any, in which granting a lien in such trademark application prior to such filing would adversely affect the enforceability or validity of such trademark application or of any registration that issues therefrom) and any new renewals thereof, including each registration and application identified on Schedule II and owned by such Grantor, (ii) the right to sue or otherwise recover for any and all past, present and future infringements, misappropriations, dilutions and other violations thereof, (iii) all income, royalties, damages and other payments then and thereafter due and/or payable with respect thereto (including payments under all licenses entered into in

connection therewith, and damages and payments for past, present or future infringements and dilutions thereof) and (iv) all other rights of any kind whatsoever accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each of the above;

(b) (i) all United States patents, patent applications, including each issued patent and patent application identified on Schedule II and owned by such Grantor, (ii) all inventions and improvements described and claimed therein, (iii) the right to sue or otherwise recover for any and all past, present and future infringements and other violations thereof, (iv) all income, royalties, damages and other payments then and thereafter due and/or payable with respect thereto (including payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof) and (v) all reissues, divisions, continuations, continuations-in-part, substitutes, renewals, and extensions thereof, all improvements thereon and all other rights of any kind whatsoever accruing thereunder or pertaining thereto;

(c) (i) all United States copyrights, whether or not the underlying works of authorship have been published, and all copyright registrations and copyright applications, and any renewals or extensions thereof, including each copyright registration and application identified on Schedule II and owned by such Grantor, (ii) the right to sue or otherwise recover for any and all past, present and future infringements and other violations thereof, (iii) all income, royalties, damages and other payments then and thereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof) and (iv) all other rights of any kind whatsoever accruing thereunder or pertaining thereto; and

(d) any and all Proceeds of the foregoing;

WHEREAS, pursuant to that certain Partial Release of Security Interest in Intellectual Property, dated as of May 9, 2022, which was recorded in the USPTO on May 9, 2022 at Reel/Frame 7715/0717, 7715/0662 and 7715/0678, and in the USCO on May 9, 2022 at Volume 15007, Doc. No. 238, the Agent released its Security Interest in certain of the IP Collateral; and

WHEREAS, the Grantors have requested that the Agent terminate and release its Security Interest in all of the remaining IP Collateral (the "Released IP Collateral").

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates and cancels the IP Security Agreements, (ii) terminates, cancels, discharges and releases its Security Interest in the Released IP Collateral and (iii) re-assigns to each Grantor any right, title or interest it may have in or to the Released IP Collateral of such Grantor, in each case without recourse to the Agent and without representation or warranty of any kind.







