TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of June 27, 2023 (“**Agreement**”), is made by WERNER CO., a Delaware corporation, located at 555 Pierce Rd., Ste 300, Itasca, IL 60143 (the “**Grantor**”), in favor of WILMINGTON TRUST, NATIONAL ASSOCIATION, a national banking association organized under the laws of the United States, with an address at 99 Wood Avenue South, Suite 1000, Iselin, New Jersey 08830, solely in its capacity as notes collateral agent (the “**Notes Collateral Agent**”). Unless otherwise defined herein, capitalized terms defined in the Collateral Agreement (as defined below) and used herein have the meaning given to them in the Collateral Agreement.

W I T N E S S E T H:

For good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantor hereby grants to the Notes Collateral Agent a lien on and a continuing security interest in all of the Grantor’s rights, title and interest in, to and under all its United States trademarks (the “**Trademarks**”) including, without limitation, the Trademarks set forth on Schedule A attached hereto, in each case together with all Proceeds and products of the Trademarks, all goodwill associated therewith, and all rights to sue at law or in equity for any infringement or other impairment thereof, including the right to receive all proceeds and damages therefrom.

This Agreement is made to secure the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of all the Secured Obligations of the Grantor, as such term is defined in the Junior Lien Collateral Agreement among the Grantor, the other assignors from time to time party thereto, the Notes Collateral Agent and certain other parties from time to time party thereto, dated as of June 27, 2023 (as amended, modified, restated, amended and restated and/or supplemented from time to time, the “**Collateral Agreement**”).

This Agreement has been granted in conjunction with the security interest granted to the Notes Collateral Agent under the Collateral Agreement. The Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of the Notes Collateral Agent with respect to the security interest granted herein are as set forth more fully in the Collateral Agreement, all terms and provisions of which are incorporated herein by reference as if fully set forth herein. In the event that any provisions of this Agreement are deemed to conflict with the Collateral Agreement, the provisions of the Collateral Agreement shall govern.


Each Grantor authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Agreement.

Wilmington Trust, National Association is entering into this Agreement solely in its capacity as Notes Collateral Agent under the Indenture and the Collateral Agreement. In entering into and acting under this Agreement, the Notes Collateral Agent shall be entitled to all of the rights, privileges, immunities and indemnities granted to it under the Indenture and the Collateral Agreement, as if such rights, privileges, immunities and indemnities were set forth herein.
