TERMINATION OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Jazwares, LLC, First Act, LLC, 1067 Studios, LLC, and Wicked Cool Toys, LLC, each a Delaware limited liability company with its principal place of business at 1067 Shotgun Road, Sunrise, Florida 33326 (collectively, the “First Grantor”), and Zag Toys, LLC, Kelly Toys Holdings, LLC, Kelly Amusement Holdings, LLC each a Delaware limited liability company with its principal place of business at 1067 Shotgun Road, Sunrise, Florida 33326 (collectively, the “Second Grantor,” and together with the Initial Grantor, the “Grantor”) are the owners of record of the Trademarks and applications listed on Exhibit A attached to this Agreement, now issued or pending (the “Trademarks”) in the United States Patent and Trademark Office (“USPTO”); and

WHEREAS, the Grantor, certain other Credit Parties (as defined in the Security Agreement), and HSBC Bank USA, National Association, as the Administrative Agent, on behalf of itself and the other Lenders, with its principal place of business at 452 Fifth Avenue, New York, NY 10018 (together with any successors and assigns thereto, the “Grantee”) entered into that certain Security Agreement, dated as of October 1, 2019, as modified by (i) a First Amendment to Security Agreement executed as of April 1, 2020 by Initial Grantors (as defined in the Security Agreement) and certain other Credit Parties, in favor of the Grantee and the Lenders, and acknowledged by the Grantee, (ii) a Second Amendment to Security Agreement executed as of September 9, 2021 by Initial Grantors and certain other Credit Parties, in favor of the Grantee and the Lenders, and acknowledged by the Grantee, and (iii) a Third Amendment to Security Agreement executed as of October 3, 2022 by the Grantor and certain other Credit Parties, in favor of the Grantee and the Lenders, and acknowledged by the Grantee (as amended, restated, supplemented or otherwise modified from time to time, collectively, the “Security Agreement”), pursuant to which, among other things, the Grantor has granted to the Grantee a lien on and security interest in, all of the Grantor’s rights, title, and interest in, to, and under, among other things, (a) all Trademarks, including, without limitation, each issued Trademark and Trademark application listed on Exhibit A hereto whether presently existing or hereafter created or acquired, (b) each Trademark License (specifically excluding, however, any Trademark License that by its terms would be defaulted by the granting of such security interest), including, without limitation, each Trademark License listed on Exhibit A hereto whether presently existing or hereafter created or acquired, and (c) all products and Proceeds of the foregoing, including, without limitation, any claim by the Grantee against third parties for past, present, or future infringement or breach of any Trademark or Trademark License, including, without limitation, any Trademarks, Trademark application, or Trademark License listed on Exhibit A hereto (collectively, the “Trademark Collateral”); and

WHEREAS, in connection with the Security Agreement, the First Grantor and the Grantee entered into that certain Trademark Security Agreement dated as of October 1, 2019, a true and correct copy of which was recorded by the USPTO on October 31, 2019, at Reel: 006789 Frame: 0169 (the “First Trademark Security Agreement”); and the Grantor and the Grantee entered into that certain Amended and Restated Trademark Security Agreement dated as of October 3, 2022, a true and correct copy of which was recorded by the USPTO on November 30, 2022 at Reel: 007918 Frame: 0015 (the “AR Trademark Security Agreement,” and together with the First Patent Security Agreement, the “Trademark Security Agreements”); and

WHEREAS, as of April 10, 2023, the Secured Obligations (as defined in the Security Agreement) have been repaid and performed in full; and

WHEREAS, the Security Agreement and the Trademark Security Agreements are terminated; and

WHEREAS, the Security Agreement and the Copyright Security Agreements are terminated; and

WHEREAS, the Grantee, as Administrative Agent for and on behalf of the Lenders, desires to release its security interest in the Trademarks and the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantee hereby:

1. releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Grantee pursuant to the Trademark Security Agreements in the Trademarks and Trademark Collateral more fully described on Exhibit A, without recourse or representation or warranty, express or implied; and

2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
