SUPPLEMENT NO. 1 (THIS "SUPPLEMENT"), DATED AS OF JUNE 20, 2023,
TO THE FOURTH AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT
DATED AS OF DECEMBER 17, 2021

WHEREAS, pursuant to the terms of that certain Fourth Amended and Restated Credit, Security, Guaranty and Pledge Agreement, dated as of December 17, 2021 (as may be amended, supplemented or otherwise modified, renewed, restated or replaced from time to time, the "Credit Agreement"; capitalized terms used herein but not otherwise defined shall have the meanings set forth in the Credit Agreement) among MRC II Distribution Company L.P., as borrower (the "Borrower"), the other Credit Parties referred to therein, together with the Borrower, collectively the "Guarantors"), Media Rights Capital II, LLC, the lenders referred to therein (the "Lenders"), and JPMorgan Chase Bank, N.A., as administrative agent (in such capacity, the "Administrative Agent") and as issuing bank (in such capacity, the "Issuing Bank"), the Lenders have agreed to make loans to the Borrower and the Issuing Bank has agreed to issue and the Lenders have agreed to participate in letters of credit for the account of the Borrower;

WHEREAS, since the execution of the Credit Agreement, various entities have submitted Instruments of Assumption and Joinder, pursuant to which each has, among other things, become a Guarantor under the Credit Agreement and a Pledgor (as defined in the Trademark Security Agreement referred to below) under the Trademark Security Agreement (such entities, the "New Pledgors");

WHEREAS, pursuant to the terms of the Credit Agreement, each of the Borrower, each Guarantor which was originally party to the Credit Agreement (but expressly exclusive of the Media Rights Capital II, LLC) (collectively, the "Existing Pledgors", and together with the New Pledgors, the "Pledgors") and (pursuant to the Instruments of Assumption and Joinder referred to above) each New Pledgor has granted to the Administrative Agent (for the benefit of the Secured Parties), a security interest in all right, title and interest of such Pledgor in and to all personal property, whether now owned, presently existing or hereafter acquired or created, including, without limitation, all right, title and interest of such Pledgor in, to and under any Item of Product and any trademark or trademark license, whether now existing or hereafter arising, acquired or created, and all proceeds thereof or income therefrom, to secure the payment and performance of the Obligations or its obligations under and in connection with its guaranty of the Obligations, as applicable, pursuant to the Credit Agreement;

WHEREAS, each of the Pledgors is a party to a Fourth Amended and Restated Trademark Security Agreement (Trademarks, Trademark Registrations, Trademark Applications and Trademark Licenses), dated as of December 17, 2021 (as the same has been, or may hereafter be, amended or supplemented from time to time, the "Trademark Security Agreement"), pursuant to which each of the Pledgors has granted to the Administrative Agent (for the benefit of the Secured Parties), as security for the Obligations or for its obligations under and in connection with its guaranty of the Obligations pursuant to the Credit Agreement, a continuing security interest in all of such Pledgor's right, title and interest in and to all of the Pledgors' trademarks and trademark licenses, whether now owned, presently existing or hereafter arising, adopted or acquired and whether or not in possession of the Pledgors, together with the goodwill of the business connected with, and symbolized by, the trademarks and all products and proceeds thereof and all income therefrom, including, without limitation, any and all causes of action which exist now or may exist

in the future by reason of infringement or dilution thereof or injury to the associated goodwill, to secure the payment and performance of the Obligations, all as more fully set forth in the Trademark Security Agreement;

WHEREAS, the New Pledgors, having joined the Credit Agreement subsequent to the original execution thereof, hold certain additional Trademark Collateral (as defined in the Trademark Security Agreement) and the Existing Pledgors hold certain additional Trademark Collateral since the date of execution of the Trademark Security Agreement;

WHEREAS, Schedule A to the Trademark Security Agreement does not reflect (i) all Item(s) of Product acquired or created by the Pledgors since the date of execution of the Trademark Security Agreement or (ii) all the Trademark Collateral held by the Pledgors;

THEREFORE,

A. Each New Pledgor hereby expressly confirms that it has assumed, and hereby agrees to perform and observe, each and every one of the covenants, rights, promises, agreements, terms, conditions, obligations, appointments, duties and liabilities of a Pledgor (as such term is defined in the Trademark Security Agreement) under the Trademark Security Agreement. By virtue of the foregoing, each New Pledgor hereby accepts and assumes any liability of the Pledgor (as such term is defined in the Trademark Security Agreement) in the Trademark Security Agreement and hereby expressly affirms each of such covenants and obligations.

B. Each of the Pledgors does hereby grant to the Administrative Agent (for the benefit of the Secured Parties), as security for the Obligations or for its obligations under and (as applicable) in connection with its guaranty of the Obligations pursuant to the Credit Agreement, a continuing security interest in and to all of such Pledgor's right, title and interest in and to the Trademark Collateral being added to Schedule A to the Trademark Security Agreement pursuant to paragraph C below, all as contemplated by, and as more fully set forth in, the Trademark Security Agreement and subject in all respects to the Credit Agreement.

C. The Trademark Security Agreement is hereby supplemented, effective as of the date hereof, by substituting Schedule A thereof with Schedule A attached hereto.

Except as expressly supplemented hereby, the Trademark Security Agreement shall continue in full force and effect in accordance with the provisions thereof on the date hereof. As used in the Trademark Security Agreement, the terms "Agreement", "this Agreement", "this Trademark Security Agreement", "herein", "hereafter", "hereto", "hereof" and words of similar import, shall, unless the context otherwise requires, mean the Trademark Security Agreement as supplemented by this Supplement.

Except as expressly supplemented hereby, the Trademark Security Agreement, all documents contemplated thereby and any previously executed Trademark Security Agreement Supplements thereto, are each hereby confirmed and ratified by each of the Pledgors.

The execution and filing of this Supplement is not intended by the parties to derogate from, or extinguish, any of the Administrative Agent's rights or remedies under (i) the Trademark Security Agreement and/or any agreement, amendment or supplement thereto or any other instrument executed by any Pledgor and heretofore recorded or submitted for recording in the United States Patent and Trademark Office or (ii) any financing statement, continuation statement, deed or charge or other instrument executed by any Pledgor and heretofore filed in any state or county in the United States of America or elsewhere.

THIS SUPPLEMENT SHALL IN ALL RESPECTS BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK APPLICABLE TO CONTRACTS MADE AND TO BE PERFORMED WHOLLY WITHIN THE STATE OF NEW YORK.

Any provision of this Supplement which is invalid, illegal or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such invalidity, illegality or unenforceability without invalidating the remaining provisions hereof, and any such invalidity, illegality or unenforceability in any jurisdiction shall not invalidate or render unenforceable such provision in any other jurisdiction.
