RELEASE OF SECURITY INTEREST
IN TRADEMARKS

Pursuant to the Security Agreement the Grantor granted to the Lender, for the benefit of certain secured parties, a security interest in and to all of Grantor's right, title and interest in Grantor's trademarks, trade names and service marks, trademark and service mark rights, trademark and service mark registrations, and applications therefor, including, without limitation, those specific trademark registrations and applications listed on Exhibit A attached hereto (the “Released Trademarks”), and the goodwill associated therewith.


The Security Agreement was recorded on March 28, 2013, at Reel/Frame 4994/0234 in the United States Patent and Trademark Office.
