**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY  
AGREEMENT**

**THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Termination"), is dated as of July 17, 2023, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "Grantee"), to **IQ BRANDS, INC. F/KA SOCK AND ACCESSORY BRANDS GLOBAL, INC.**, a Delaware corporation, **TWIN CITY KNITTING COMPANY, INC.**, a North Carolina corporation, and **ARGYLE HOLDINGS, INC.**, a Delaware corporation (each, a "Grantor", and collectively, the "Grantors").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of April 18, 2018, made by Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the patent division of the United States Patent and Trademark Office on April 23, 2018, at Reel/Frame 045607/0551, with the trademark division of the United States Patent and Trademark Office on April 23, 2018, at Reel/Frame 6319/0114, and with the United States Copyright Office on April 24, 2018, at Volume 9951, Document 984;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.




