**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of July 13, 2023, by CAPITAL ONE, NATIONAL ASSOCIATION, as administrative agent (in such capacity, together with its successors and permitted assigns in such capacity, “Agent”) for the Secured Parties. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement or the Trademark Security Agreement (each as defined below), as applicable.

WITNESSETH:

WHEREAS, BioPlus Specialty Pharmacy Services, LLC, a Florida limited liability company (f/k/a BioPlus Specialty Pharmacy Services, Inc.) (“BioPlus”), Exact Care Pharmacy, LLC, an Ohio limited liability company (“Exact Care”, and together with BioPlus, each, individually, a “Grantor”, and, collectively, the “Grantors”), as grantors, the other grantors party thereto, and Agent are parties to that certain Security Agreement, dated as of May 14, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, the Grantors and Agent are parties to that certain Trademark Security Agreement, dated as of May 14, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), pursuant to which each Grantor granted to Agent a lien on and security interest in, to and under the Trademarks as security for certain obligations owing by such Grantor to Agent;

WHEREAS, the Trademark Security Agreement was recorded by the Assignment Recordation Branch of the United States Patent and Trademark Office on May 14, 2020, at Reel 6938, Frame 0577 and at Reel 6938, Frame 0557; and

WHEREAS, each Grantor has satisfied the obligations secured by the Trademark Security Agreement and has requested that Agent release its lien on and security interest in, to and under the Trademarks and reassign any and all rights in the same to such Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its lien on and security interest in, to and under all of each Grantor’s respective right, title and interest in, to and under the Trademarks, which includes but is not limited to the following:

- (a) all of its Trademarks and all Trademark Licenses providing for the grant by or to such Grantor of any right under any Trademarks, registrations and all applications for registration thereof, including, without limitation, those referred to on Schedule 1 hereto;
- (b) all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark;

(c) all renewals and extensions of the foregoing; and

(d) all income, fees, royalties, damages, claims and payments asserted at any time due and/or payable under and with respect to any of the foregoing, including, without limitation, damages and payments for past, present or future breach thereof, all rights to sue for past, present or future breach or other violations thereof.

2. Agent hereby reassigns, grants and conveys to each Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in, to and under the Trademarks. Agent hereby authorizes each Grantor (or their designee) to file this Release with the United States Patent and Trademark Office.


