TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“Termination and Release”), dated as of August 4, 2023, is made by WHITEHAWK CAPITAL PARTNERS LP, as agent (the “Agent”) in favor of GREENLANE HOLDINGS, INC., ARI LOGISTICS, B.V., CONSCIOUS B.V., GLOBAL PACIFIC HOLDINGS LLC, GREENLANE HOLDINGS, LLC, GREENLANE HOLDINGS EU B.V., GS FULFILLMENT LLC, HSCM LLC, HS MALIBU LLC, KCH DISTRIBUTION INC., KIM INTERNATIONAL LLC, KUSH ENERGY, LLC, KUSH SUPPLY CO. LLC, MERGER SUB GOTHAM 2, LLC, ROCKETMANG LLC, SHAVITA B.V., SOUTH ATLANTIC HOLDINGS LLC, VAPE WORLD DISTRIBUTION LTD., WAREHOUSE GOODS LLC, 1095 BROKEN SOUND PKWY LLC, POLLEN GEAR LLC, and HS PRODUCTS LLC (each a “Grantor” and, collectively, the “Grantors”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the IP Security Agreement (as defined below) or the Loan Agreement (as defined in the IP Security Agreement), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain U.S. Intellectual Property Security Agreement, dated as of August 8, 2022 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “IP Security Agreement”) by and among Agent and the Grantors, each of the Grantors granted a security interest in all Secured Intellectual Property in favor of the Agent, which was recorded in (i) the trademark division of the United States Patent and Trademark Office on August 9, 2022 at Reel 7816, Frame 0593, (ii) the patent division of the United States Patent and Trademark Office on August 9, 2022 at Reel 061133, Frame 0327, (iii) the United States Copyright Office on August 9, 2022 at Volume 15008, Doc. No. 897.

WHEREAS, the Grantors have satisfied in full their obligations under the Loan Agreement and the IP Security Agreement and requests a release of the security interest in the Secured Intellectual Property granted thereunder; and

WHEREAS, the Agent now desires to terminate the IP Security Agreement and terminate and release its security interest in the Secured Intellectual Property, including the trademark registrations, trademark applications, patents, patent applications and copyrights listed on Schedule A hereto, and to reassign any and all rights, title, and interest in the same to the Grantors, as provided herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Agent, for itself and for the benefit of the Secured Parties, hereby irrevocably terminates the IP Security Agreement and irrevocably discharges, cancels, relinquishes

terminates and releases, in its entirety, for the benefit of the Grantors and their successors and assigns, its Lien on and security interest in and to the Secured Intellectual Property and any and all right, title and interest of the Agent in and to the Security Intellectual Property, including those trademark registrations, trademark applications, patents, patent applications and copyrights set forth on Schedule A.

2. The Agent hereby assigns, grants and conveys to the each applicable Grantor, without any representation, warranty, recourse or undertaking by the Agent, any and all of the Agent's right, title, and interest in and to such Grantor's Secured Intellectual Property, including those trademark registrations, trademark applications, patents, patent applications and copyrights set forth on Schedule A, including all goodwill associated therewith.

3. The Agent agrees to execute, acknowledge, procure and deliver all further documents and do all such other acts as may be reasonably required or desirable to carry out the purposes of this Termination and Release, including to effect the release of the Agent's security interest contemplated hereby.


