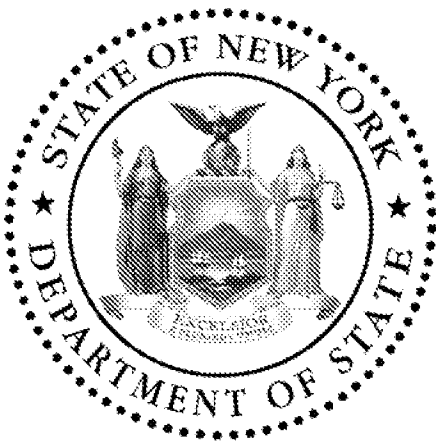

Under Section 1003 of the New York Limited Liability Company Law

**FIRST:** The name (and if the name has been changed, the name under which it was formed) and jurisdiction of formation or organization of each limited liability company or other business entity that is to merge is:

- a) First Quality Products, Inc., a New York corporation. The name under which First Quality Products, Inc. was originally formed is "First Quality Products Inc." and
- b) First Quality Products, LLC, a Delaware limited liability company. The name under which First Quality Products, LLC was originally formed is "First Quality Products, LLC".

**SECOND:** For each domestic limited liability company and domestic other business entity, the date when its initial articles of organization or formation document was filed with Department of State is: October 17, 1988.

**NINTH:** The Secretary of State is designated as agent of the surviving foreign limited liability company upon whom process against it may be served.



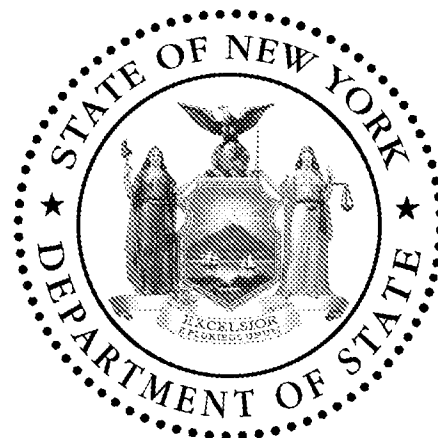
