NOW THIS ASSIGNMENT WITNESSES that, for good and valuable consideration paid by the Assignee to the Assignor, the receipt of which is hereby acknowledged, the Assignor hereby assigns to the Assignee the Marks, for all of the goods and/or services included in the relevant applications and registrations, or in conjunction with which the Marks are used, together with the goodwill of the business associated with and symbolized by the Marks, and the right of the Assignee to bring actions and claim relief in respect of any infringement or other violation of rights with respect to the Marks occurring prior to the date hereof.

The Assignor agrees that it will cooperate fully with the Assignee in completing any further documents which shall be reasonably requested by the Assignee in order to complete the assignment of right, title, and interest to the Marks.


