RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (“Release”), effective as of July 21, 2023, given by Credit Suisse AG, Cayman Islands Branch, as Administrative Agent (“Agent”) to VistaJet Limited (“Grantor”), as follows:

WITNESSETH

WHEREAS, the Grantor executed that Guarantee and Collateral Agreement, dated as of June 25, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) and granted to the Agent a security interest in the United States trademark registrations and applications set forth on Schedule A attached hereto, and other related rights as set forth in Section 2 of the Trademark Security Agreement (the “Trademarks”) to secure the Obligations (as defined in the Security Agreement);

WHEREAS, in furtherance of the Security Agreement, the Grantor executed a Trademark Security Agreement, dated June 25, 2019 (the “Trademark Security Agreement”), which was recorded by the U.S. Patent and Trademark Office on June 25, 2019, at Reel 6692 and Frame 0537;

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to terminate the encumbrance created by the Trademark Security Agreement and the Security Agreement in respect of the Trademarks.


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, without recourse or warranty, the Agent hereby terminates, releases, cancels, relinquishes and discharges the security interest in the Trademarks created by the Trademark Security Agreement and the Security Agreement and reassigns all right, title and interest it has in the Trademarks to the Grantor. No security interest is being released other than in respect of the Trademarks.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE GRANTOR’S AND THE ADMINISTRATIVE AGENT’S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
