RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 25th day of August, 2023, by LBC CREDIT AGENCY SERVICES, LLC, in its capacity as agent ("Agent"), in favor of VERINEXT CORP., a Pennsylvania corporation (the "Company").

RECITALS

The Company and the Agent entered into (i) that certain Intellectual Property Security Agreement, dated as of June 21, 2019, which was recorded at the United States Patent and Trademark Office on June 21, 2019 at Reel 6675 and Frame 0863, and (ii) that certain Supplement to Intellectual Property Security Agreement, dated as of October 23, 2020, which was recorded at the United States Patent and Trademark Office on October 23, 2020 at Reel 054152 and Frame 0478 (each a "Security Agreement" and, collectively, the "Security Agreement").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged:

1. Release and Termination of Security Agreement. Each Security Agreement is hereby terminated and Agent hereby releases, discharges, terminates and cancels all liens and security interests granted by the Company in favor of Agent in all trademarks, including the trademarks listed on Schedule A attached hereto (the "Trademark Collateral"). The Company hereby acknowledges and accepts the foregoing release and assignment by the Agent. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under a Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Company.
2. Authorization. The Agent hereby authorizes the Company, at the expense of the Company, to file this Release in the applicable filing and recording offices to effect a complete release of the Trademark Collateral.
3. Further Assurances. The Agent agrees to take all further actions, and provide to the Company and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Company, at the Company's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
