## **SECOND SUPPLEMENT TO ABL TRADEMARK SECURITY AGREEMENT**

This **SECOND SUPPLEMENT TO ABL TRADEMARK SECURITY AGREEMENT** (this “Second Supplement”) is made as of August 23, 2023 by **FULLBEAUTY BRANDS OPERATIONS, LLC**, an Indiana limited liability company, (the “Grantor”) in favor of **CITIZENS BANK, N.A.**, as Collateral Agent (the “Collateral Agent”).

**WHEREAS**, reference is made to that certain ABL Trademark Security Agreement, dated as of February 7, 2019, and recorded with the United States Patent and Trademark Office (the “USPTO”) on February 8, 2019 at Reel 006556 Frame 0245 (the “Original Grant”), executed and delivered by certain Grantors (as defined therein) party thereto in favor of the Collateral Agent, pursuant to which such Grantors pledged, assigned and granted a security interest in certain ABL Collateral (as defined therein);

**WHEREAS**, the Original Grant was supplemented by that certain First Supplement to ABL Trademark Security Agreement, dated as of December 19, 2022, and recorded with the USPTO on December 19, 2022 at Reel 007925 Frame 0294 (the “First Supplement”, and together with the Original Grant, the “Grant”); and

**WHEREAS**, the Grantor has developed and/or acquired additional ABL Collateral and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional ABL Collateral to the extent owned by the Grantor as set forth on Schedule A-1 hereto in favor of the Collateral Agent.

**NOW, THEREFORE**, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
2. Supplement to Schedule A. Schedule A to the Grant is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto. For the purposes of clarity, from and after the date hereof, Schedule A shall be deemed to include (i) the ABL Collateral referenced on Schedule A as such Schedule A exists immediately prior to the date hereof (including as supplemented pursuant to the First Supplement), and (ii) the ABL Collateral referenced on Schedule A-1 annexed hereto.
3. Miscellaneous:
  - a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.


- b. This Second Supplement and the Grant cover the entire understanding of the parties with respect to the matters set forth herein and supersede all prior discussions and negotiations hereon.
