

AFFIDAVIT OF TRADEMARK OWNERSHIP

I, Paul Breaux, being an authorized representative of ADESA US Auction, LLC, have personal knowledge of the facts stated herein and am competent to attest to these facts and certify the following:

1. Pursuant to that certain Securities and Asset Purchase Agreement dated as of February 24, 2022 (“SAPA”), Carvana Group, LLC (“Carvana”) agreed to acquire the ADESA US business from KAR Auction Services, Inc. (“KAR”) (the “ADESA Acquisition”). Under the SAPA, KAR had an obligation to transfer all of the intellectual property assets owned by KAR and its affiliates that are exclusively related to the ADESA US business (“Transferred IP”) to ADESA US Auction, LLC prior to the closing of the ADESA Acquisition.
2. The Transferred IP included the intellectual property listed in Section 2.11 of the Seller Disclosure Letter (as defined in the SAPA), and the trademarks included in such Transferred IP are listed in Exhibit A attached hereto.
3. Therefore, ADESA US Auction, LLC became the owner of the Transferred IP prior to the closing of the proposed transaction, including the trademarks listed on Exhibit A attached hereto.
4. The ADESA Acquisition closed on May 9, 2022, and as a result Carvana acquired ADESA US Auction, LLC from KAR.
5. We hereby request and authorize the United States Patent and Trademark Office to record the change in ownership to reflect ADESA US Auction, LLC as indicated above and in the attached document.



