RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of September 1, 2023 by WILMINGTON SAVINGS FUND SOCIETY, FSB, in its capacity as Collateral Agent for the Secured Creditors (in such capacity, the “Collateral Agent”), in favor of BOARDRIDERS IP HOLDINGS, LLC, a California limited liability company, and DC SHOES, INC., a California corporation (the “Grantors” and each, a “Grantor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement, or if not defined therein, in the Security Agreement (as defined below).

WHEREAS, each Grantor is a party to that certain (i) Security Agreement, dated as of August 31, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) in favor of the Collateral Agent, and (ii) Trademark Security Agreement, dated as of August 31, 2020, in favor of the Collateral Agent (the “Trademark Security Agreement”), pursuant to which each Grantor unconditionally granted, collaterally assigned and pledged to the Collateral Agent, for the benefit of the Secured Creditors, a continuing security interest (the “Security Interest”) in the Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 7052, Frame 0001 on September 15, 2020;

WHEREAS, each Grantor has requested that the Collateral Agent terminate, release and discharge fully the Security Interest in the Trademark Collateral, including each trademark and trademark application listed on the attached Schedule A hereto, and execute a document suitable for recording in the United States Patent and Trademark Office to evidence the release of the Security Interest in the Trademark Collateral as herein provided.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without representation or warranty of any kind, hereby releases, relinquishes and discharges the Security Interest in the Trademark Collateral, and re-assigns to each Grantor any and all right, title or interest it may have in the Trademark Collateral of such Grantor.


The Collateral Agent hereby authorizes each Grantor, or such Grantor’s authorized representatives, to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. The Collateral Agent agrees to execute and deliver to each Grantor such other instruments and other documents (in form and substance satisfactory to the Collateral Agent) prepared by and reasonably requested by a Grantor to release the Security Interest in the Trademark Collateral which had been granted under the Security Agreement and the Trademark Security Agreement.

THE VALIDITY OF THIS RELEASE, THE CONSTRUCTION, INTERPRETATION, AND ENFORCEMENT HEREOF, AND THE RIGHTS OF THE COLLATERAL AGENT AND THE GRANTORS WITH RESPECT TO ALL MATTERS ARISING HEREUNDER OR RELATED HERETO SHALL BE DETERMINED UNDER, GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
