## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of September 20, 2023 by BANK OF AMERICA, N.A., a national banking association, as agent (in such capacity, "*Agent*") for certain lenders (the "*Lenders*"), in favor of Q.E.P. CO., INC., a Delaware corporation, as assignee of QEP - TENNESSEE, INC. (in such capacity, "*Grantor*").

WHEREAS, pursuant to that certain Collateral Assignment of Trademarks and Security Agreement, dated as of February 12, 2010 (the "*Trademark Security Agreement*"), between Grantor and Agent which was recorded with the U.S. Patent and Trademark office on February 12, 2010 at Reel 4153 and Frame 0844, Grantor granted to Agent, for the ratable benefit of the Lenders, a security interest in, among other property, certain intellectual property;

WHEREAS, Agent desires to release the security interest held by Agent in certain Trademarks (as defined in the Trademark Security Agreement) and reassign any and all rights in the same to Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby terminates and releases its lien on and security interest in, to and under all of Grantor's right, title and interest in, to and under the Trademarks identified on Exhibit A hereto (the "*Subject Trademarks*") and other rights associated with the Subject Trademarks in which Agent was granted a security interest pursuant to the Trademark Security Agreement. In addition, Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in, to and under the Subject Trademarks. For the avoidance of doubt, Agent is not releasing and does not intend to release any Trademarks other than the Subject Trademarks.

2. Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
