## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, by that certain Intellectual Property Security Agreement dated July 21, 2017 (“Security Agreement”), originally recorded in the Trademark Assignment Branch of the United States Patent and Trademark Office (“PTO”) by that certain Notice of Grant of Security Interest in Intellectual Property on August 8, 2017 at Reel/Frame 6125/0287, Focus Consumer Healthcare, LLC, a Delaware limited liability company with an address at 801 Broad Street, suite 600, Chattanooga. Tennessee 37402 (“Grantor”), granted to Pinnacle Bank, a Tennessee banking corporation, with a mailing address of 801 Broad Street, Suite 100, Chattanooga.
