**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of October 2, 2023, (this “Release”) is made by JPMORGAN CHASE BANK, N.A., as Administrative Agent for the Secured Parties (in such capacity, the “Administrative Agent”) under the Amended and Restated Pledge and Security Agreement (as amended, supplemented or modified and in effect from time to time, the “Security Agreement”), dated as of June 30, 2009, between SUGAR FOODS CORPORATION, a New York corporation (the “Grantor”) and the Administrative Agent. Capitalized terms used but not defined herein have the meanings provided in the Security Agreement.

WHEREAS, pursuant to the Security Agreement which was recorded at the United States Patent and Trademark Office on July 13, 2009, at Reel 4023 and Frame 0300, the Grantor granted to the Administrative Agent a continuing security interest in all of Grantor’s right, title and interest in all Copyrights, Patents and Trademarks (the “Intellectual Property”), including those set forth on the attached Schedule 1.

WHEREAS, Grantor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Intellectual Property (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Released Collateral, and (d) reassigns, grants and conveys to Grantor any and all right, title and interest it has in the Released Collateral. Following the date hereof, the Administrative Agent agrees to execute and deliver such further instruments and take such additional action as the Grantor, or its successor in interest, or the United States Patent and Trademark Office may reasonably request to effect or consummate the transactions contemplated hereby.

This Release shall be governed by and construed and interpreted in accordance with the internal laws of the State of New York but excluding any principles of conflicts of law or other rule of law that would cause the application of the law of any jurisdiction other than the laws of the State of New York. Any signature delivered by email in “PDF” or similar format shall be deemed an original signature hereto.
