INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "**Agreement**"), is made as of September 27, 2023, by and among Nielsen & Bainbridge, LLC, a Delaware limited liability company with an address at 12303 Technology Boulevard, Suite 950, Austin, Texas 78727 ("**Nielsen**"), Patton Picture Company, an Ohio corporation with an address at 12303 Technology Boulevard, Suite 950, Austin, Texas 78727 ("**Patton Picture**"), Cheyenne Products, LLC, a Delaware limited liability company with an address at 12303 Technology Boulevard, Suite 950, Austin, Texas 78727 ("**Cheyenne Products**"), Jimco Lamp & Manufacturing Company, an Ohio corporation with an address at 12303 Technology Boulevard, Suite 950, Austin, Texas 78727 ("**Jimco**" and, together with Nielsen, Patton Picture, and Cheyenne Products, each, a "**Seller**" and, collectively, the "**Sellers**"), and New View Gifts & Accessories, Ltd., a Pennsylvania corporation with an address at 311 East Baltimore Avenue, Media, Pennsylvania 19063 ("**Purchaser**").

Sellers and Purchaser are parties to that certain Asset Purchase Agreement, of even date herewith (the "**Purchase Agreement**"), pursuant to which, among other things, Sellers have agreed to assign to Purchaser all of Sellers' rights, title and interests in the Assigned Intellectual Property (defined below).

In consideration of the premises, the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the parties hereby covenant and agree as follows:

1. Sellers hereby sell, assign, transfer and convey to Purchaser in perpetuity all of Sellers' right, title and interest in and to the Transferred Assets (as that term is defined in the Purchase Agreement) owned by Sellers, including, without limitation, the Trademarks set forth on Exhibit A attached hereto and all goodwill associated with and the business appurtenant to and symbolized by the Transferred Assets (collectively, the "**Assigned Intellectual Property**"), the same to be held and enjoyed by Purchaser, its successors, permitted assigns or legal representatives, together with associated income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for injunctive relief, restitution, damages or payments by reason of unauthorized use of the Assigned Intellectual Property, along with the right to sue for past, present and future violations and seek the same for Purchaser's sole use and enjoyment, provided that, with respect to the United States intent-to-use applications identified in Exhibit A, the transfer of such applications will occur after a statement of use or amendment to allege use, as applicable, has been filed with and accepted by the USPTO. Sellers hereby authorize the United States Commissioner of Trademarks and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Agreement upon request by Purchaser.
2. Nothing in this Agreement shall alter any liability or obligation of Sellers or Purchaser arising under the Purchase Agreement, which shall govern the obligations of the parties with respect to the Assigned Intellectual Property.
3. From time to time following the date hereof, Sellers shall execute and deliver, or cause to be executed and delivered, to Purchaser such other instruments of assignment and transfer as Purchaser may reasonably request or as may be otherwise necessary to more effectively assign and transfer to, and vest in, Purchaser and put Purchaser in possession of, any benefit of the Assigned Intellectual Property.
4. This Agreement shall inure to the benefit of and be binding upon the successors and assigns of Purchaser and the successors and assigns of Sellers.
5. This Agreement shall be governed by, and construed in accordance with, the internal laws of the State of Texas without regard to the laws of any other jurisdiction that might be applied because of the conflicts of laws principles of the State of Texas. All disputes, controversies, claims, actions and other proceedings involving, directly or indirectly, any matter in any way arising out of, related to, or connected with, this


Agreement or the relationship between the Parties, and any and all other claims of Purchaser against a Seller of any kind, shall be brought only in the United States Bankruptcy Court for the Southern District of Texas, Houston Division or, solely to the extent that such Bankruptcy Court declines to exercise jurisdiction, in a state court located in the State of Texas, and each Party consents, to the fullest extent permitted by law, to the jurisdiction of any such court and waives any and all rights the Party may have to object to the jurisdiction of any such court, or to transfer or change the venue of any such action or proceeding, including, without limitation, any objection to venue or request for change in venue based on the doctrine of *forum non conveniens*. Each Party consents to service of process in any action or proceeding brought against it by any other Party, by personal delivery, or by mail addressed as set forth in this Agreement or by any other method permitted by law.

6. This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which, when taken together, shall constitute one and the same instrument. Facsimile and electronic signatures are acceptable and shall be deemed original signatures.
