TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “*Termination and Release*”) is granted as of October 27, 2023 by **CITIZENS BANK, N.A.**, a national banking association, individually as a Lender, and as Administrative Agent for itself and other financial institutions (the “*Agent*”), in favor of **AQUITY SOLUTIONS, LLC**, a Delaware limited liability company (the “*Grantor*”).

WHEREAS, the Grantor executed and delivered that certain Trademark Security Agreement dated as of August 14, 2019 (the “*2019 Agreement*”) pursuant to which the Grantor granted to the Agent a security interest in and lien on certain trademarks and trademark applications as described more fully therein (the “*Original Marks*”), which Grant was recorded with the United States Patent and Trademark (“*USPTO*”) on August 15, 2019 at Reel 006720, Frame 0800;

WHEREAS, the Grantor executed and delivered that certain First Supplement to Trademark Security Agreement dated as of September 13, 2021 (the “*2021 Supplement*”, and together with the 2019 Agreement, collectively the “*Trademark Security Agreements*”) pursuant to which the Grantor granted to the Agent a security interest in and lien on certain trademarks and trademark applications as described more fully therein (the “*Supplemental Marks*” and together with the Original Marks, collectively, the “*Marks*”), which 2021 Supplement was recorded with the USPTO on September 13, 2021 at Reel 7420, Frame 0079;

WHEREAS, the Grantor has requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Marks as herein provided; and


WHEREAS, the Grantor has requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent’s security interests in and liens on the Marks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under (i) the Marks, including without limitation those trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications identified in Schedule A hereto, (ii) all proceeds and products of the Marks, (iii) all goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same;
2. assigns, transfers and conveys to the Grantor any interest in all of the foregoing, including any lien and security interest thereof; and
3. authorizes and requests that this Termination and Release be recorded with the USPTO.
