RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 2, 2023, (this "Trademark Release") is made by GLAS AMERICAS LLC, as collateral agent (the "Collateral Agent") under the Collateral Agreement dated October 20, 2021, as amended, modified, restated or supplemented from time to time (the "Collateral Agreement"), by and among Collateral Agent and WPG HOLDINGS LLC (the "Parent" and "Borrower Representative"), the direct and indirect Subsidiaries of the Parent listed on the signature pages of the Collateral Agreement (together with the Parent, the "Initial Grantors"), and any Additional Grantor (as defined below) who is or may become party to the Collateral Agreement (such Initial Grantors and Additional Grantors, collectively, the "Grantors"). Capitalized terms used herein have the meanings provided in the Collateral Agreement dated October 20, 2021 as amended, modified, restated or supplemented from time to time (the "Collateral Agreement").

WHEREAS, pursuant to the Collateral Agreement and Notice of Grant of Security Interest in Trademarks dated October 20, 2021, Grantors granted to the Collateral Agent a continuing security interest and continuing lien upon all of such Grantor's right, title and interest in, to and under the Trademarks (as defined in the Collateral Agreement) and trademark applications owned by such Grantors shown on Schedule 1 attached thereto for the ratable benefit of the Secured Parties (as defined in the Collateral Agreement) and all Proceeds (as defined in the Collateral Agreement) and products of such Trademarks and Trademark applications.

WHEREAS, Grantors have requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of Collateral Agent's security interest in and liens to the Trademarks and trademark applications owned by Grantor under the Collateral Agreement and Notice of Grant of Security Interest in Trademarks, shown on Schedule 1 hereto (the "Released Trademark Collateral"), including all goodwill thereto.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, without recourse, representation or warranty of any kind, hereby terminates, extinguishes, cancels, discharges and releases, any and all right, title and interest, including its security interest in and liens to the Released Trademark Collateral, all goodwill connected with the use of, and symbolized by, each Released Trademark Collateral; all renewals and extensions of the foregoing; and all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all claims, causes of action, and rights to sue and recover at law or in equity for any past, present and future infringement, dilution, or other violation thereof; and Collateral Agent reassigns to the person or persons legally entitled thereto all rights, title and interest in the Released Trademark Collateral.


