**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of November 7, 2023, is made by **JPMORGAN CHASE BANK, N.A.**, as Administrative Agent (the "Administrative Agent"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Credit Agreement, dated as of January 5, 2021 (as the same has since been amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), among Avid Technology, Inc., a Delaware corporation ("Grantor"), the Lenders, and Administrative Agent, the Lenders agreed to make loans and extend other financial accommodations to or for the benefit of the Grantor;

**WHEREAS**, the Grantor, and certain subsidiaries of the Grantor, entered into that certain Pledge Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), dated as of January 5, 2021 in favor of the Administrative Agent;

**WHEREAS**, in connection with the Credit Agreement, Security Agreement and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "Trademark Security Agreements"), the Grantor granted security interests in certain intellectual property owned by the Grantor, including without limitation, the trademarks listed on Annex I attached hereto (the "Trademarks"); and

**WHEREAS**, the Trademark Security Agreements were recorded in the United States Patent and Trademark Office, on the dates and on the reels/frames or volume/document no., as applicable, set forth on Annex I attached hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself and as Administrative Agent for the Secured Parties, hereby irrevocably **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the Trademarks, whether granted pursuant to the Security Agreement, the Trademark Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in, to and under the Trademarks to the Grantor.

The Administrative Agent, without representation or warranty of any kind, acknowledges the automatic termination and cancellation of, and hereby terminates and cancels, the Trademark Security Agreements.

The Administrative Agent agrees, at the Grantor's sole expense, to cooperate with the Grantor and to provide the Grantor with any information and additional authorization reasonably required or desirable (including, without limitation, the execution and delivery of any and all documents or other instruments) to effect the release of the security interest held by the Administrative Agent, on behalf of itself and as Administrative Agent for the Secured Parties, in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
