RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

THIS RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS, dated as of November 9, 2023, (this “Release”) is made by JPMORGAN CHASE BANK, N.A. (“Grantee”), for itself and as Administrative Agent for the Secured Parties, under the Confirmatory Grant of Security Interest in United States Trademarks (as amended, supplemented or modified and in effect from time to time, the “Trademark Security Agreement”), between NXGN MANAGEMENT, LLC, a California limited liability company (the “Grantor”) and the Grantee. Capitalized terms used but not defined herein have the meanings provided in the Trademark Security Agreement.


WHEREAS, pursuant to the Trademark Security Agreement which was recorded at the United States Patent and Trademark Office on March 15, 2021 at Reel 7221 and Frame 0119, the Grantor granted to the Grantee a continuing security interest in all of Grantor’s right, title and interest in Trademarks, including those set forth on the attached Exhibit A, together with the goodwill of the business symbolized by Grantor’s Trademarks.

WHEREAS, Grantor has requested and the Grantee has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Grantee does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Grantee in the Released Collateral, and (d) reassigns, grants and conveys to Grantor any and all right, title and interest it has in the Released Collateral.
