**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (“Trademark Release”) is made as of October 24, 2023, by **BANK OF AMERICA, N.A.**, as collateral agent (the “Collateral Agent”), in favor of **CIENA CORPORATION**, a Delaware corporation with an address at 7035 Ridge Road, Hanover, Maryland 21076 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain Trademark Security Agreement dated October 28, 2019 (the “Trademark Security Agreement”) with the Collateral Agent, notice of which was recorded on October 29, 2019 at the United States Patent and Trademark Office at Reel 6782, Frame 0564.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of Grantor’s right, title and interest in, to and under all of the Trademark Collateral.

WHEREAS, Grantor has satisfied the terms of the Trademark Security Agreement and requests a specific release of the security interest granted and recorded against its intellectual property.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, without representation or warranty of any kind, for itself and on behalf of the lenders in association with the Security Interest, hereby:

- (a) releases, terminates and discharges any and all of its interest of Grantor in and to all intellectual property (including, but not limited to, all Trademark Collateral under the Trademark Security Agreement), whether granted pursuant to the Trademark Security Agreement or otherwise (and including, but not limited to, the Trademarks listed on Schedule A attached hereto);
- (b) assigns and transfers to Grantor all of its right, title and interest in and to all intellectual property, whether granted pursuant to the Trademark Security Agreement or otherwise (including, but not limited to the Trademarks listed on Schedule A attached hereto), together with the goodwill of the business symbolized thereby; and
- (c) authorizes the recordation of this Trademark Release with the USPTO or any similar office or agency within or outside of the United States at the Grantor’s expense.

This Trademark Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
