**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is executed effective as of November 15, 2023, by FIRST MERCHANTS BANK, an Indiana bank, as administrative agent for the Lenders under the Credit Agreement referred to below ("Agent"), in favor of SBS AMERICA, LLC, a Delaware limited liability company (the "Grantor"). Unless otherwise indicated, capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Credit Agreement as referred to below.

WHEREAS, reference is made to that certain Credit Agreement dated as of November 22, 2021 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among Grantor, RENOVATE AMERICA HOLDING CORP., an Indiana corporation ("Holdings"), SBS HOLDINGS, LLC, a Delaware limited liability company ("SBS", together with Holdings, "Borrowers"), Agent and the other Lenders party thereto;

WHEREAS, the Grantor executed a certain Trademark Security Agreement dated as of November 22, 2021 for the benefit of the Agent (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") pursuant to which the Grantor granted to the Agent a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined therein) (the "Security Interest"), including the Trademarks listed on Exhibit A hereto, in order to induce the Agent to make Loans;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at reel 7503 frame 0380 on November 23, 2021 ("USPTO"); and

WHEREAS, the Agent has agreed to terminate and release its Security Interest with respect to the Trademarks listed on Exhibit A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Agent has released, terminated and discharged the Security Interest granted under the Trademark Security Agreement with respect to the Trademarks listed on Exhibit A hereto, and any right, title or interest of the Agent in such Security Interest in such Trademarks listed on Exhibit A are terminated and void. This Release does not release, relinquish, discharge or terminate the Agent's security interest in any Intellectual Property or any other asset of the Grantor other than the Trademarks set forth in Exhibit A hereto. The Agent hereby consents to the recording of this Release with the USPTO and agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest with respect to the Trademarks listed on Exhibit A as contemplated hereby.


