RELEASE OF TRADEMARK SECURITY AGREEMENT

This RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”) is made as of December 7, 2023, by Bank of America, N.A. in its capacity as Collateral Agent for the Secured Parties under (and as defined in) the Security Agreement referred to below (the “Collateral Agent”) for the benefit of Option Care Infusion Services, Inc., a Delaware corporation, Critical Care Systems, Inc., a Delaware corporation, Option Care Enterprises, Inc., a Delaware corporation, Clinical Holdings, Inc., an Ohio corporation, BioScrip, Inc., a Delaware corporation, HomeChoice Partners, Inc., a Delaware corporation, InfuScience, Inc., a Delaware corporation, Option Care, Inc., a California corporation and Infusion Partners, LLC, an Ohio limited liability company (individually, a “Grantor”, and, collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement (as defined below) or the Trademark Security Agreement (as defined below) as applicable.

W I T N E S S E T H:

WHEREAS, the Grantor and the Collateral Agent are parties to that certain ABL Trademark Security Agreement, dated as of August 6, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”); pursuant to which the Grantor has granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Grantor in, to and under the Trademarks (including, without limitation, registered Trademarks and Trademark applications of such Grantor listed on Schedule I attached hereto, all renewals and extensions of the foregoing, all goodwill of the business connected with the use of, and symbolized by the foregoing, any and all claims for damages and injunctive relief for past, present and future infringement, misappropriation, violation or misuse with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages and any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing) (collectively, the “Trademark Collateral”); and

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on August 7, 2019 at Reel 6714 and Frame 0247; and

WHEREAS, Grantor has requested that the Collateral Agent release, and the Collateral Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Trademark Collateral, including, without limitation, the trademarks set forth on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent does hereby irrevocably terminate, release and discharge the entirety of any and all liens or security interests that it may have in or on, and all claims to, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement

or Trademark Security Agreement, the Trademark Collateral, including, without limitation, those set forth on Schedule I hereto, and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby terminate, cease and become void. The Collateral Agent hereby assigns, transfers and conveys any and all right, title or interest of the Collateral Agent in, to, or under the Trademark Collateral to the Grantor.

2. The Collateral Agent, on behalf of itself and the Secured Parties, does hereby terminate and cancel the Trademark Security Agreement.

3. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

4. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
