**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 13, 2023 (this "Termination"), is made by Sixth Street Specialty Lending, Inc., a Delaware corporation, as Administrative Agent (in such capacity, including any successor thereto, the "Administrative Agent") for the Secured Parties under that certain Trademark Security Agreement, dated as of November 8, 2021 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among Tops Markets, LLC, a New York limited liability company, Tops PT, LLC, a New York limited liability company and The Golub Corporation, a Delaware corporation (each a "Grantor" and together the "Grantors") and the Administrative Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on November 08, 2021 at reel 7487, frame 0178, each Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a lien on and security interest in all of such Grantor's right, title and interest in, to and under all of its Trademark Collateral, including, without limitation those set forth on the attached Schedule A;

WHEREAS, the obligations secured by the Trademark Collateral have been repaid; and

WHEREAS, each Grantor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the Trademark Security Agreement and liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release and relinquish its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in, and the security interest granted to the Administrative Agent in the Released Collateral. The Administrative Agent agrees, or authorizes the Grantors, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantors to evidence the release and termination of the Administrative Agent's security interests in the Released Collateral.


THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.


