## TRADEMARK SECURITY AGREEMENT

### (Trademarks and Trademark Licenses)

TRADEMARK SECURITY AGREEMENT, dated as of December 18, 2023, between the Grantors listed on Annex 1(a) and 1(b) (the “Grantors” and each, a “Grantor”), and ROYAL BANK OF CANADA, as collateral agent (in such capacity, the “Collateral Agent”).

WHEREAS, each Grantor owns, or in the case of Trademark Licenses is a party to, the Trademark Collateral (as defined below);

WHEREAS, MARQUEE BRANDS INTERMEDIATE HOLDINGS II LLC, a Delaware limited liability company (the “Borrower”), MARQUEE BRANDS INTERMEDIATE HOLDINGS I LLC, a Delaware limited liability company (“Holdings”), the other Grantors (as defined below) from time to time party hereto and the Collateral Agent, are parties to a Security Agreement, dated as of December 18, 2023 (as may be amended, extended, restated, amended and restated, supplemented, waived or otherwise modified and as heretofore amended and/or supplemented, the “Security Agreement”), under which each Grantor secures the Secured Obligations;

WHEREAS, pursuant to (i) the Security Agreement, and (ii) certain other Security Documents (including this Trademark Security Agreement), each Grantor secures the Secured Obligations by granting to the Collateral Agent for the benefit of the Secured Parties a continuing security interest in the Collateral of each Grantor, including all right, title and interest of each Grantor in, to and under the Trademark Collateral (as defined below);

WHEREAS, pursuant to the Security Agreement, each Grantor agreed to execute this Trademark Security Agreement in order to record the security interest in the Trademark Collateral granted to the Collateral Agent for the benefit of the Secured Parties with the United States Patent and Trademark Office; and

WHEREAS, terms defined in the Security Agreement (or whose definitions are incorporated by reference in Section 1 of the Security Agreement) and not otherwise defined herein have, as used herein, the respective meanings provided for therein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to and upon the terms and conditions contained in the Security Agreement, each Grantor, to secure the payment and performance of the Secured Obligations, hereby grants to the Collateral Agent for the benefit of the Secured Parties a continuing security interest in all of the following property owned by each Grantor, whether now owned or existing or hereafter acquired or arising (all of the following items or types of property being herein collectively referred to as the “**Trademark Collateral**”):

(i) each United States Trademark constituting Recordable Intellectual Property owned by each Grantor, including, without limitation, each Trademark registration and application (excluding any Intent-to-Use application) referred to in Schedule 1 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each Trademark;

(ii) all past, present and future claims or causes of action arising out of any infringement or

other violation or impairment of any of the foregoing, and the right to sue or otherwise recover therefor; and

(iii) all Proceeds of the foregoing including without limitation license fees, royalties, income, claims, damages, proceeds of suit and other payments now or hereafter due and/or payable with respect thereto;

*provided* that, notwithstanding anything herein to the contrary, 1) in no event shall the Trademark Collateral include any Excluded Assets, and 2) upon filing of the appropriate statement of use, the Intent-to-Use applications will automatically become part of the Trademark Collateral.

THE PARTIES HERETO AUTHORIZE AND REQUEST THAT THE COMMISSIONER OF PATENTS AND TRADEMARKS OF THE UNITED STATES RECORD THIS SECURITY INTEREST IN THE TRADEMARK COLLATERAL.

Upon any termination or release of the security interest in the Trademark Collateral pursuant to paragraphs 15(a) through 15(c) of the Security Agreement, the Collateral Agent shall promptly execute and deliver to each Grantor all UCC termination statements, releases of Intellectual Property Filings, and similar documents and take such other actions as each Grantor shall reasonably request in writing to evidence such termination or release.



Each Grantor acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the provisions of this Trademark Security Agreement and the provisions of the Security Agreement, the provisions of the Security Agreement shall govern.
