GRANT OF SECURITY INTEREST IN TRADEMARKS

This Trademark Security Agreement (this "Trademark Security Agreement") is made as of December 21, 2023, by CAMPAGNA-TURANO BAKERY, INC. (the "Grantor"), in favor of JPMORGAN CHASE BANK, N.A., as Lender (together with its successors and assigns in such capacity, the "Grantee").

WHEREAS, the Grantor has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the attached Schedule A, which trademarks and servicemarks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, the Grantor has entered into a Security and Pledge Agreement, dated December 21, 2023 (as further amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), in favor of the Grantee; and

WHEREAS, pursuant to the Security Agreement, the Grantor has granted to the Grantee for the benefit of the Secured Parties, a continuing security interest in all right, title and interest of the Grantor in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (other than the Excluded Property, the "Collateral"), to secure the payment, performance and observance of the Obligations.

NOW, THEREFORE, as collateral security for the payment, performance and observance of all of the Obligations, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor does hereby confirm its grant to the Grantee, for the benefit of the Secured Parties, of a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations, pursuant to the terms of the Security Agreement.

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.


