## RELEASE AND TERMINATION OF TRADEMARK SECURITY AGREEMENT


This RELEASE and TERMINATION, dated as of August 9, 2018, is made by ACF FINCO I LP, a Delaware limited partnership with a place of business at 580 White Plains Road, Suite 610, Tarrytown, New York 10591 ("*Lender*").

WHEREAS, ICE HOUSE AMERICA, L.L.C., a limited liability company organized under the laws of the State of Florida and TWICE THE ICE HOLDINGS, L.L.C., a limited liability company organized under the State of Florida (collectively, the "Assignor") and Lender entered into a Trademark Security Agreement dated as of December 30, 2015 and recorded at the U.S. Patent and Trademark Office on April 5, 2016, at Reel 5765, Frame 0888 in which the Assignor granted a security interest to Lender in certain Trademarks that the Assignor then owned.
