**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 20, 2023 (“Release”), is made by PNC Bank, National Association, as Administrative Agent (“Administrative Agent”) in favor of Sun Hydraulics Corporation, a Florida corporation, Enovation Controls, LLC, an Oklahoma limited liability company, and Sun Hydraulics, LLC, a Florida limited liability company (each a “Grantor”, and collectively, the “Grantors”).

**WHEREAS**, pursuant to that certain Patent, Trademark and Copyright Security Agreement, dated as of November 22, 2016 (as amended by that certain Guarantor Joinder and Assumption Agreement, dated as of December 5, 2016 and as further amended by that certain First Amendment, Consent and Joinder to Credit Agreement, dated as of April 1, 2018, as may be further amended, restated, supplemented or otherwise modified from time to time in accordance with its terms, the “Security Agreement”) by and among the Grantors and Administrative Agent, and the Acknowledgement of Security Interest in Intellectual Property dated as of April 3, 2018, (“Acknowledgement”), by and among the Grantors and Administrative Agent, each Grantor granted to the Administrative Agent, for the benefit of the Lenders, a continuing security interest in the Collateral, including the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, “Trademark Collateral”); and

**WHEREAS**, the Acknowledgement was recorded at the United States Patent and Trademark Office (“USPTO”) on June 29, 2018 at Reel 6368 Frame 0473.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Lenders, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Acknowledgement.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of the Lenders, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in solely the Trademark Collateral listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Acknowledgement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

**IN WITNESS WHEREOF**, the Administrative Agent, on behalf of the Lenders, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
