**TERMINATION AND RELEASE OF
AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Termination and Release of Amended and Restated Intellectual Property Security Agreement, dated as of December 27, 2023 (this “*Release*”) is made with regard to that certain Amended and Restated Intellectual Property Security Agreement entered into as of April 14, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time from time to time, “*Agreement*”) by and between **CANADIAN IMPERIAL BANK OF COMMERCE** (“*Administrative Agent*”) and **BLOOMERANG, LLC**, an Indiana limited liability company (the “*Grantor*”). Capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Agreement or the A&R Credit Agreement, as applicable.

WHEREAS, Administrative Agent agreed to make certain advances of money and to extend certain financial accommodations to the Grantor in the amounts and manner set forth in that certain Amended and Restated Credit Agreement, dated as of April 14, 2023, by and among Administrative Agent, the Grantor, the Guarantors from time to time party thereto and the Lenders from time to time party thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “*A&R Credit Agreement*”).

WHEREAS, pursuant the Agreement, which was recorded on April 14, 2023 at Reel 063336, Frame 0254 in the Patent division of the U.S. Patent and Trademark Office, the Grantor granted Administrative Agent a security interest in the patents listed in the Exhibit B hereto (collectively, the “*Patents*”).

WHEREAS, pursuant the Agreement, which was recorded on April 14, 2023 at Reel 8042, Frame 0317 in the Trademark division of the U.S. Patent and Trademark Office, the Grantor granted Administrative Agent a security interest in the trademarks listed in the Exhibit C hereto (collectively, the “*Trademarks*”).

WHEREAS, the Grantor has paid and satisfied in full its Obligations under the A&R Credit Agreement, and the parties desire to enter into this Release to confirm that Administrative Agent has released its security interests in and to the Intellectual Property, including the Patents and Trademarks, and to expunge any recordation of the security interest insofar as it pertains to the Intellectual Property, including the Patents and Trademarks.

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby forever terminates, releases and discharges the entire security interest in and to all of the Intellectual Property, including the Patents and Trademarks.

Administrative Agent hereby agrees to execute such instruments, to take such other actions, and to give such further assurances as the Grantor reasonably shall request to terminate any security interest in the Intellectual Property pursuant to the Agreement and otherwise to effectuate the release of all recordations of such security interest in the Intellectual Property. This Release may be recorded by or for the Grantor with the U.S. Patent and Trademark Office.

Administrative Agent acknowledges and agrees that the Grantor and its successors and assigns may rely upon this Release. Administrative Agent represents and warrants that it has not transferred or assigned all or any part of the security interest in the Intellectual Property to any third party, and that it has all necessary authority to execute this Release and grant the releases and discharges and all other rights set forth herein.
