TERMINATION AND RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Termination and Release of Security Interest in Intellectual Property (“Release”) is made as of March 20, 2024, by MACQUARIE CAPITAL FUNDING LLC, a Delaware limited liability company (in such capacity, together with its successors and assigns, “Collateral Agent”) in favor of DIVERSIFIED PROJECT MANAGEMENT, INC., a New Hampshire corporation with an address at 27 Richmond Road, Hudson, New Hampshire 03051, STV GROUP, INCORPORATED, a Pennsylvania corporation with an address at 205 West Welsh Drive, Douglassville, Pennsylvania 19518 and STV INCORPORATED, a New York corporation with an address at 225 Park Avenue South, New York, NY 10003 (each a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain intellectual property security agreement dated December 13, 2019 (the “IP Security Agreement”) with Collateral Agent, notice of which was executed for filing with the United States Copyright Office and United States Patent and Trademark Office, and which was recorded on December 13, 2019 at the United States Patent and Trademark Office at Reel 6815, Frame 0878.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of each such Grantor’s right, title and interest in and to the Collateral, including without limitation the Trademarks and Copyrights listed in Schedule A (collectively, the “IP Collateral”).


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such IP Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the IP Collateral of each of the Grantors, and assigns, transfers and conveys to Grantors (any interest in such intellectual property, including the Security Interest.
