RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN)

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN)** (this “**Release**”) is made as of March 28, 2024 by ALTER DOMUS (US) LLC, as the Collateral Agent (in such capacity, the “**Collateral Agent**”), in favor of AVENTIV TECHNOLOGIES, LLC, SECURUS TECHNOLOGIES, LLC (f/k/a SECURUS TECHNOLOGIES, INC.), JPAY LLC (f/k/a JPAY INC.), SATELLITE TRACKING OF PEOPLE LLC and ALLPAID, INC. (f/k/a GOVERNMENT PAYMENT SERVICE, INC.) (each individually, a “Grantor”, and, collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreements (defined below), or if not defined therein, in the Security Agreement (defined below).

WHEREAS, each Grantor is a party to that certain (i) Second Lien Security Agreement, dated as of November 1, 2017 (as amended by that Amendment Agreement dated as of August 10, 2023 and as may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) by and among Grantors, the other Grantors (as defined therein) and the Collateral Agent, (ii) Second Lien Trademark Security Agreement, dated as of November 1, 2017, by Securus Technologies, LLC, JPAY, LLC and Satellite Tracking of People LLC in favor of the Collateral Agent, which was recorded with the United States Patent and Trademark Office at Reel 6196, Frame 0001, on November 3, 2017, Second Lien Trademark Security Agreement, dated as of February 14, 2018, by GOVERNMENT PAYMENT SERVICE, INC. (now ALLPAID, INC.) in favor of the Collateral Agent, which was recorded with the United States Patent and Trademark Office at Reel 6274, Frame 0627, on February 16, 2018, Second Lien Trademark Security Agreement, dated as of May 20, 2021, by Securus Technologies, LLC, JPAY, LLC and Satellite Tracking of People LLC in favor of the Collateral Agent, which was recorded with the United States Patent and Trademark Office at Reel 7305, Frame 0694, on May 25, 2021, Second Lien Trademark Security Agreement, dated as of August 04, 2023, by Aventiv Technologies, LLC, Securus Technologies, LLC, JPAY, LLC and Satellite Tracking of People LLC in favor of the Collateral Agent, which was recorded with the United States Patent and Trademark Office at Reel 8168, Frame 0942, on August 15, 2023 (collectively, the “**Trademark Security Agreements**”);

WHEREAS, pursuant to that certain Agreement of Agent Resignation, Appointment and Acceptance, dated as of December 29, 2023 (the “**Agency Replacement Date**”), by and among SCRS Acquisition Corporation (the “**Holdings**”), Aventiv Technologies, LLC (the “**Borrower**”), WILMINGTON SAVINGS FUND SOCIETY, FSB (“**WSFS**”), and Collateral agent, WSFS has resigned as collateral Agent under the Security Agreement, effective as of the Agency Replacement Date and the Collateral Agent will act as the successor to DBNY as the collateral agent under the Security Agreement effective as of the Agency Replacement Date;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreements, Grantors pledged and granted to the Collateral Agent a lien on and security interest in all of Grantors’ right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth on **Schedule A** hereto;

WHEREAS, each Grantor has requested that the Collateral Agent terminate, release, relinquish and discharge fully its lien on and security interest in all right, title and interest of each Grantor in and to the Trademarks, and execute a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its lien on and security interests in the Collateral as herein provided.


NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without representation or warranty of any kind, and without recourse to it, hereby terminates, releases, relinquishes and discharges the lien on and security interest in and to the Trademarks granted to it under Security Agreement and the Trademark Security Agreements, and assigns and re-assigns to each Grantor any and all right, title or interest it may have under the Security Agreement and the Trademark Security Agreements in such Trademarks.

THIS RELEASE AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK.
