**GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

Each of the Grantors authorizes and requests that the Commissioner of Trademarks record this Agreement.

**THIS GRANT** (the “**Grant**”), dated as of April 1, 2024, is made to secure the satisfactory performance and payment of all the Obligations of the Grantors, as such term is defined in the Pledge and Security Agreement by, among others, the Grantors and the Grantee, dated as of the date hereof (as amended, modified, restated and/or supplemented from time to time, the “**Security Agreement**”). Each of the Grantors does hereby acknowledge and confirm that the grant of the security interest herein, and the rights and remedies of the Grantee with respect to the security interest granted herein, are more fully set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.


This Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.

This Grant may be executed in any number of counterparts each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.




